Each person signing this Application in any capacity covenants to give written notification to Mucky Wear 90 day prior to closure or any change in ownership of Merchant and the intended date of such change.

Merchant stipulates that placing an order with Mucky Wear constitutes doing business in the State of Utah. Merchant stipulates that exclusive jurisdiction and exclusive venue for all matters related to any account between Merchant and Mucky Wear shall be the Third District Court, in and for Salt Lake County, Utah and Merchant irrevocable agrees to be bound by any judgment rendered in such court. In any dispute related to any account between Merchant and Mucky Wear the prevailing party is entitled to its attorney fees in addition to any other damages, award, or remedy.

All invoice accompanying any products advanced by Mucky Wear to Merchant are due and payable according to the terms listed on the invoice accompany such products. Discounts taken after the discount date will not be honored and will be charged back to the Merchant's account. Returned checks will forfeit all discounts. There is a \$50.00 service charge for any returned check. All past due balances related to invoices for products advanced to Merchant after the date of this Application will be assessed a 10% late fee penalty plus accruing interest at the rate of 2% per month. In the event of default, Merchant authorizes Mucky Wear, without court action, to physically repossess any inventory advanced to Merchant by Mucky Wear and/or file UCC security instruments in the name of Merchant creating security interests in the same.
