This agreement establishes the binding agreement terms below upon purchase of this pack:

1. The Contents within this pack are 100% Royalty Free (meaning we are not seeking royalties in the form of monetary payment).
2. When purchasing this pack you are purchasing a license to use the Contents therein.
3. Sounds in this pack cannot be used alone (or as is) and must be accompanied by other musical arrangements (including but not limited to drums, keys, synths, vocals, guitars, etc.).
4. The contents of this pack can be used for music production purposes (beat production, songs, instrumentals, beats for rappers, music for vocalist, etc.).
5. Writers Credit is mandatory (Meaning we ARE seeking credit as writers/composers for **ANY** registered works done using the contents within this pack).
