- Expo hours of operation are:

- Separate Exhibitor parking will be provided adjacent to the building. Security will be provided for this parking area and the venue.
- Loading times will be assigned and you will be notified by September 1<sup>st</sup>.

### Food and Drink Vendors Only

- All Food and Drink will be served outside from 10am to 9pm on Friday and Saturday and 10am to 4pm on Sunday.
- Vendors must be approved by and follow all regulations and requirements of the Mobile Department of Health.
- Vendors must have insurance covering injuries to third parties that might occur from sale or distribution.
- Food and Drink Vendors can only sell Coca-Cola beverages as outlined in The Grounds contract. Vendors may place an order through The Grounds to receive Coke products if needed.
- No more than two vendors of the same type will be allowed.

## Agreement to Operate Booth

## **Terms of Contract**

- Failure by Exhibitor to make payment as agreed to in this Application & Contract will result in termination of all rights of the Exhibitor herein and any payments by Exhibitor prior to said time shall be retained by G&D Farms Outdoor Expo as liquidated damages for the breach of this agreement and G&D Farms Outdoor Expo may recall sold space.
- G&D Farms Outdoor Expo will not be liable for any loss or damage to the property of the Exhibitor, or its employees, due to fire, robbery, accidents, or any cause whatsoever that may arise from use and occupancy of leased space.
- Exhibitors must provide their own public liability insurance.
- G&D Farms Outdoor Expo reserves the right to reject any application, refuse space or close any booths, sales or displays deemed detrimental to the success of the G&D Farms Outdoor Expo or in violation of venue rules or local ordinances.
- G&D Farms Outdoor Expo reserves the right to make location/space changes, with no advance notice to the exhibitor, that will, in the opinion of the Expo, be of benefit to the show.
- Concession space is not transferable, nor may it be subdivided.
- No firm or organization not assigned a space in the exhibit will be permitted to solicit business within the exhibit area or on the venue premises.
- In the event that the event is not held for any reason, the rental and lease space to the exhibitor shall be cancelled and terminated upon the return of the deposit or rental paid by exhibitor for space in the area or building for this specific event. Return of money will terminate any liability upon G&D Farms Outdoor Expo.

## **Rules and Regulations**

- Exhibitors must provide everything necessary to conduct operation.
- Booths must be occupied by at least one attendant during the hours of Expo operation.
- Exhibitors must show only goods manufactured or dealt in by them in the regular course of business.
- Any visible, unfinished framework must be draped or otherwise finished by the Exhibitor.
- Bulk space exhibits or island type areas are not considered a standard booth and will not include a standard booth set up.
- Exhibitors will not be allowed to store visible empty packing boxes or crates in booths during the exhibit hours of operation.
- All booth decorations must be flame-proofed and all hangings must clear the floor.
- All electrical use in the exhibit must comply with OSHA National Electrical Code.
- No noise-making devices or speaker systems will be allowed.
- No extension into the aisles or obstruction of other exhibits will be permitted.
- No Exhibit may be dismantled before 4pm on Sunday without written permission of G&D Farms Outdoor.
- All Exhibitors must clean their spaces after the event and leave them in the same condition they were in upon arrival.
- Failure to remove the entire booth set up and/or complete cleaning will result in a \$1000 fine.
