

Explanation the nuances of a Same or Similar denial and
how you can successfully appeal this denial

Same or Similar

Within the past several months many of you may have experienced (or heard from a colleague about) a DME denial due to “**Same or Similar**”. This presentation will help explain the nuances of a Same or Similar denial and how you can successfully appeal this denial.

History: The Same or Similar policy has been in place for some time. Recently the DME MAC have become stricter in enforcing this policy. The rationale for this policy originates from a past Congressional Federal Register regulation, deeming a 5-year useful lifetime for AFO’s. Thus the 5-year rule is “hard wired” into the DME MAC AFO Policy. Medicare’s notion is that they are already paying for one device and will not pay for another same or similar device for the same condition during this time period.

This thought process has critical flaws which can best be illustrated by two common clinical examples:

1) A patient presents to your (or another providers office) in 2016 and is diagnosed with left foot plantar fasciitis and some mild ankle arthritis. They are dispensed an off the shelf night brace (L4397) and NDADIS. In January 2019, the patient's left ankle arthritis has progressed sufficiently to require a custom fabricated AFO (e.g. L1970). The custom AFO (L1970) is denied because they previously received a night brace (L4397) three years ago.

2) A patient sustained a minor stroke in September 2015 with a resultant mild right drop foot requiring a dorsiflex assist hinged custom fabricated AFO (L1970 + L2210). In December 2018, the patient suffered another stroke and now presents with a complete right drop foot. Your examination concludes they now require a solid AFO (L1960). The solid AFO you dispensed in February 2019 is denied because of the hinged brace previously dispensed in 2015.

Inquiring on a Potential Same or Similar Denial

Using either your DME MAC Provider Portal (preferable) or Interactive Voice Response (IVR) systems, you can submit information on your patient and perform a search inquiry to determine whether another provider dispensed a Same or Similar AFO to the patient within the last 5 years. If your inquiry reveals another AFO was previously dispensed within the 5-year time period, it is essential to document why the device previously dispensed device is medically inappropriate. As important is justifying the medical necessity for the new device.

Appealing a Same or Similar Denial

is both possible and easier than you might think. The above common scenarios and documentation excerpts are drawn from real past experiences. Having the appropriate information prior to dispensing a second device, will enable you to reinforce your documentation from its inception. This crucial information embodied in your chart, may also be submitted to the DME MAC via their portal as part of the appeals process. This will allow the nurse reviewer to gain insight into your patient's new medical necessity issues, allowing for a successful review and overturn of the initial Same or Similar denial.

IVR or Portal?

Both are free, however, the DME MAC Provider Portal is a more efficient method of not only obtaining Same or Similar information, but for submitting your appeal documents. Initial access to the portal may be a challenge, but it is time well spent. At the end of this tutorial we have provided some screen shots from Noridian's Provider Portal to illustrate the simplicity of obtaining Same or Similar Information.

Which Codes Should I Check?

The following AFO codes (see table 1) were derived from the Same or Similar AFO policy. Use the range feature on your DME MAC portal to check and see if any of the codes were previously dispensed within a specified 5-year time period.



1) Once you have logged onto Noridian's Provider Portal, click the Same or Similar Inquiry Button. Then enter all the requested information.



2) After you have entered all the requested information about you and your patient, use the “2” code range button and select the code range as L1900 through L4631. This should provide you with a comprehensive view of any AFO’s provided within the last five years.

Then submit the inquiry. If the patient has received any AFO devices within the last five years then a very detailed list of the dispensed AFO's will be provided which you can print and save to your patient's chart as a PDF. (PDF)
