The .150 is 8" long and the .150S is 6" long (S stands for Short)

- PASGT line of helmets
- o Rubber seal provides a liquid barrier at the helmet band/shield interface

#### Locking mechanism

- Interchangeable right to left side
- o Locks 1" aluminum band in stowed or deployed positions
- o One-hand release

### Slide ratchet securing system

- Quickly and securely attaches band tightly to helmet
- Single finger release lever

#### Helmet shell dual retention locks

- Situated on both sides of the band, hook to the helmet shell at the base of the shells ear mold
- Adjusts to Full or Mid Cut helmet cuff.
- Keeps face shield from being jarred loose from the helmet
