STEP 1

Install Holster

Remove T-plate from belt loop by unscrewing the 1/8th hexdrive screw from the hinge assembly. Separate hinge, if the hinge is stuck, rotate hinge assembly to break tension, or lightly tap the bottom of the T-plate.

Install T-plate onto your choice of Safariland holster using 3 Safariland $8-32 \times 3/8$ screws (1104461) or $8-32 \times 1/4$ screws (1104461) and 3 Safariland leather washers (1119158) or nylon washers (1166730) depending on individual holster needs.

Reinstall T-plate and holster subassembly onto belt loop. Snug down the hinge's 1/8th hexscrew hand tight for adjustment later.



STEP 2

Configure Belt Size

USPSA Kit2 is designed to be used with 1.5" (38mm) and 1.75" (45mm) width competition belts via the use of a belt shim. The belt shim comes preinstalled in the belt clamp for the 1.5" (38mm) configuration. With the belt shim removed the belt clamp is in the 1.75" (45mm) configuration.



The belt clamp is designed to press tightly against the interior face of the belt. Using the 4 screws on the belt clamp, tighten until there is no movement between the belt and belt loop.



STEP 3

Adjust as Necessary

Pitch: Pitch is adjusted on the T-plate by loosening the 3 screws connecting the holster and T-plate, rotating the holster to desired pitch angle and retightening the screws.

Yaw: Yaw is adjusted by loosening the hinge screw and rotating the holster to desired yaw angle and retightening the screw.

Ride Height: Ride height is adjusted by moving the hinge assembly up or down the series of holes in the hanger plate.

STEP 4

ELS Configuration

USPSA Kit2 can be configured to work with the Safariland ELS mounts. Remove the belt clamp from the hanger plate. Install male ELS fork onto the hanger plate with 3 screws, utilizing the top 2 screw holes from the belt clamp. NOTE: More pitch angle can be achieved by adjusting the angle of the ELS fork.



PRACTICE

Regular practice to assure proficiency in using the holster must be continued if it is to be used. The amount of practice and training required will depend upon dexterity, coordination and prior experience with holsters and handguns of each user.

CARE AND MAINTENANCE

WARNING: Never store your Safariland holster or accessories near a heat source. Space heaters, radiators, heating registers, fireplaces, or other heating sources emit high temperatures that can deform or destroy the polymer from which many Safariland products are manufactured.
