



Instructions for filling out the **MANUFACTURER'S STATEMENT OF ORIGIN**

1. Please download this form to your computer to enable editing.
2. Fields in **red** are required.
3. The statement of origin is page 2 of this document.
4. In the top section please **TRIPLE** click into the first box to clear the default text and start typing. You can then tab between fields.
 - a. Enter the date of purchase and invoice number.
 - i. Leave invoice number blank if unknown.
 - b. Enter your name and address in the respective boxes.
 - c. The second address line is optional, all others are required.
 - d. Enter the model year, not the year purchased. The last two digits of the serial number indicate the year it was manufactured. (ex: *RRG12345A123*, would be *2023*)
 - e. Enter the description of the kayak from the invoice.
 - f. Enter the serial number on your kayak. This typically starts with RRG and is located behind the seat or near the rear storage compartment.
 - g. Enter the boat length from the invoice / description.
5. Print this form

Instructions for filling out the Assignment section

You can simply print the form and hand write the information in or:

1. Fill in the name and address of the recipient
2. If you have a lien fill in the information about that including the :
 - a. Amount of lien
 - b. Date of lien
 - c. Name of lien holder
 - d. Address of lien holder
3. Fill in your name and position.
4. Have your notary fill in the rest.
5. Print the form
6. Sign the form, and have your notary stamp their seal.
