**Skin Contact:** Gently brush away excess solids. Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 5

minutes or until the product is removed, while holding the eyelid(s) open. Obtain medical advice immediately if irritation occurs. Take special care if exposed person is wearing contact lenses.

#### **SECTION 6: ACCIDENTAL RELEASE MEASURES**

Minor spills do not normally need any special clean-up measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Stop leak if safe to do so, and contain spill. ## Exposure Standards:

A time weighted average (TWA) concentration for an 8 hour day, and 5 day week has not been established by Worksafe Australia for any of the major ingredients in this product. There is a blanket limit of 10mg/m<sup>3</sup> for dusts or mists when limits have not otherwise been established. The nature of this product makes it unlikely that this level will be approached in normal use.
