4. FIRST AID MEASURES

Description of first aid measures

Methylcellulose

General advice:

Inhalation: Move person to fresh air; if effects occur, consult a physician.

Wash clothing before reuse. Discard items which cannot be decontaminated, including leather articles such as shoes, belts and watchbands.
