





## INTRODUCTION




## INSTALLATION

Before selecting which camera mount to use, it is best to determine where in the car the Car Baby Camera will best be placed in order to capture the image of your baby's car seat. Make sure the Car Baby Camera is not located near the airbag. If your car seat is rear or forward facing you have several options:


## **Option 1: Headrest Mount with Straps**

Use the Headrest Mount with Straps to attach to the headrest of the front or back seat by pulling the vertical and horizontal straps and securing with the plastic ladder lock buckle. The Car Baby Camera should be mounted tightly to the headrest so that the Car Baby Camera is stable. The Car Baby Camera can then be adjusted to angle accordingly to capture the entire car seat. Adjust the angle of the Car Baby Camera by loosening the nut and rotate to your desired angle.



## **Option 2: Spring Loaded Clamp**

To mount the Car Baby Camera using the clamp around the headrest pole that best suits the Car Baby Camera placement that is needed. Attach the Car Baby Camera on the bracket of the clamp. Adjust the angle of the Car Baby Camera by loosening the nut and rotate to your desired angle.




## **CONNECT TO POWER**

The Car Baby Camera comes with a 9.8 ( ) USB-C Power Cable which can be plugged into any available USB media port in your vehicle.

Starting with the power cable plugged to the base of the Car Baby Camera. Ensure that the cable is not in contact with the car seat or within reaching distance of the baby. It is recommended to tuck the cable behind the seat, lining, rug or panels in order to keep it from tangling or getting caught in any object.

Once you have the Car Baby Camera secure in its mount, and the power cable tucked carefully out of the way, you can plug the power cable into the USB media port.



**NOTE:** If your vehicle does not have a media port you need to connect the power cable to the 12/24V power socket through a USB power adapter 10 (not included in this package).

## **USAGE PRECAUTIONS**

Many vehicles provide constant power to the provides constant power, please remember to unplug the Car Baby Camera when not in use to avoid draining of the vehicle's battery.

## DOWNLOADING THE APP





The Car Baby Camera auto sme function enables you to control and play back recorded media files using your smartphone with the YADA Drive APP. Scan the QR code on the right or search "YADA Drive" in the APP Store or Google Play. Download and install the APP.





Compatible with iPhone 4s and higher, iPad3, iPad Mini, iPad Air and higher, and iPod touch 5th Generation and higher. Requires iOS 9.0 or higher.





Compatible with phones with Android $^{\text{TM}}$  5.0 or higher.

## **APP SETUP**

#### Auto-sync the Car Baby Camera with your smart device

- 1. Power on the Car Baby Camera, it will enter WiFi pairing mode automatically.
- 2. Launch the YADA Drive APP and tap on the BABY MONITOR category.
- 3. Select In Car Baby Monitor Camera from the list. Tap on Set Up Device.

#### Android device

- 4. Tap the (i) icon and then the Pair Camera Icon.
- 5. The APP will search for to Baby Camera's SSID "YADA BBC01 1080P XXXXXX." Tap Connect.
- 6. The APP will as you to setup your Car Baby Camera's PIN for first time connection. Make sure you remember your password. To reset your password, please refer 12 to the APP's 1 Info icon.









8. You should see the live view of the Car Baby Camera if the connection is successful.



## iOS device (Follow steps 1-3 from previous page's instructions)



- 4. Tap the icon and then the Pair Camera Icon.
- 5. Tap Settings on the PP permissions setting page. Scroll to the top, and press to enter the WiFi setting page.
- 6. Choose the Car Baby Car SSID "YADA\_BBC01\_1080P\_XXXXXX."
- 7. Tap on the YADA Drive icon to retute the APP.



8. The APP will ask you to setup your Car Baby Camera's PIN for first time connection. Make sure you remember your password. To reset your password, please refer to the APP's 1 Info icon.

9. You should see the live vie the Car Baby Camera.

**NOTE:** Tap on the into icon for more on-screen instructions.

The Car Baby Monitor is a system that is intended as an aid to monitor your baby while you are driving by allowing for quick glances at your baby while facing forward and without having to turn around and take your eyes off the road. It is not a substitute for responsible and proper adult supervision of children and should not be used as such.

Make sure that at no time does the Car Baby Monitor Camera or cables come in any contact or within reach of your baby.

This product will only provide images of items that are within the field of view of the camera. Thus, it is imperative that the camera should be kept clean and unobstructed. And should be mounted so that its field of view includes the entire area around the car seat.

The Car Baby Monitor is made for use indoor or inside your vehicle. It is not meant for outdoor use. Do not get any of the Car Baby Monitor components wet or exposed to moisture. At any time, do not attempt to disassemble the camera, or use different cables other than the ones provided with the original packaging.

The car seat should be correctly mounted in the car as required by law. There is no need to have the baby in the car while the Car Baby Monitor is installed, and should be kept away as a precaution.

Before mounting the camera, check your local laws and regulations

regarding where the device is legally allowed to be mounted.

The camera should be mounted securely as instructed. At no time should it be loose or not fixed to the headrest.

DO NOT attach the camera to the car seat. DO NOT lay the camera loosely in the car seat.

This system is powered by plugging the USB-C power cable provided in this package into your vehicle's USB media port. Do not attempt to use any other power source or cables to operate this system.

The Car Baby Monitor is not a toy. At no time should children be allowed to play with it. It should only be operated by adults who have read the safety and operating instructions listed in this manual.

This product contains small parts. Adult installation is required. Exercise care when unpacking and assembling the product.

#### Strangulation Hazard:

Children have STRANGLED in cables. Keep the unit and cable more than 3 feet from the crib or car seat and out of baby's reach. NEVER place camera or cables within the crib or car seat. Secure the cable more than 3 feet away from the baby's reach.

## **MAINTENANCE & WARRANTY**

#### Cleaning

- If dirt, rain water droplets, snow or mud adhere to the camera lens, rinse with water and wipe with a dry cloth.
- Do not use alcohol or thinner to clean the camera. This will cause discoloration. To clean the camera, wipe with a clean cloth dampened with mild cleaner diluted with water and then wipe with a dry cloth.
