INSTRUCTIONS

1. Form A shall be used where the data subject wishes to object to the processing of his or her personal data, on grounds relating to his or her particular situation, in any of the following situations:

The processing of your personal data is being carried out on the basis of a public interest mission or in the exercise of public powers vested in the controller.

The processing of my personal data is being carried out on the basis of the satisfaction of legitimate interests pursued by the controller or a third party.

In these first two cases, the mere exercise of the right of opposition entails the limitation of the right to object.

The processing of my personal data is being carried out for scientific or historical research or statistical purposes.

Form B. shall be used where the data subject wishes to object to the processing of his or her personal data for direct marketing purposes, including profiling.

2. It will be necessary to provide a photocopy of the ID card or equivalent document that proves the identity and is considered valid in law, in those cases in which the person responsible has doubts about his identity. In the event of acting through legal representation, the ID card and document accrediting the representation of the representative must also be provided.

3. The Spanish Data Protection Agency does not have your personal data and can only provide the contact details of the Data Protection Officers of the entities obliged to appoint one who have notified their appointment to the Agency. It can also provide these contact details for those entities that have voluntarily appointed a Delegate and have communicated it.

4. The owner of the personal data undergoing processing must contact directly the public or private body, company or professional of which he/she presumes or is certain that he/she holds the data.

5. In order for the Spanish Data Protection Agency to be able to process your claim in the event that your request to exercise your right of objection has not been answered, it is necessary that one month has elapsed without the data controller having exercised the right, and you provide any of the following documents:

- the refusal of the data controller to oppose the requested data.
- a copy stamped by the data controller of the form for requesting objection.
- a copy of the application form stamped by the post office or a copy of the receipt for sending it by registered post.
- any other means of proof provided by the controller from which receipt of the request can be deduced
