EQUIPMENT RENTAL AGREEMENT TERMS & CONDITIONS

This Equipment Rental Agreement (“Agreement”) is effective as of the date of last signature (“Effective Date”), and is made between Lay-z-day’s, a Event Corporation organized under the laws of United Kingdom, Located Telford Shropshire (“Lay-z-days Hot tubs & Event’s”) And (“Renter”). Owner and Renter are hereinafter collectively referred to as “Parties”.

Owner rents to Renter and Renter rents from Owner, subject to the terms and conditions of this Agreement:

1. Term. This Agreement shall commence on the Effective Date and remain in full force and effect until Equipment is returned to Lay-z-day’s Event’s. Renter shall return the Equipment on Date arranged unless terminated earlier consistent with the terms herein.
2. Payment. Renter shall pay the full balance before hire commences and authorize Payment to Lay-z-day’s Event’s to an amount equal to all payments and fees due under this Agreement.
3. Renter shall also pay other charges in accordance with this Agreement due upon return of Equipment, Please see below, This being to the fullest extent allowed by law, including:
 4. a) Charges for optional services, if any;
 5. b) applicable taxes;
 6. c) loss of, or damage or repair to the Equipment, loss of use, diminution of the Equipment’s value caused by damage to it or repair to it, and costs to enforce such charges including administrative fees for processing the claim and legal expenses;
 7. d) a £100.00 charge per Day for late return of the Equipment or the highest amount allowable under law;
 8. e) unless due to the fault of Lay-z-days Event’s, all fines, penalties, court costs and other expenses relating to the Equipment assessed against Lay-z-days Event’s or the Equipment during the rental Term;
 9. f) all expenses Lay-z-days Event’s incurs due to Renter’s failure to return the Equipment including costs in locating and recovering the Equipment;
 10. g) all costs incurred to collect unpaid monies due; and
 11. h) the maximum amount allowed by law, whichever is greater.

Prior To Delivery

Ensure The access is clear, remove any Wheelie Bins etc from alleyways or doors. If there are we will not be held responsible for any damage caused to your property during the delivery process.

Please ensure the health and safety of our delivery staff during the delivery process by providing them with a clear, trip free access route.

If you have pets please ensure that your garden is clear of any pet waste before the delivery.

Measure the area to make sure there is adequate space for your Equipment. Lay-z-days Events reserves the right to charge any booking deposit paid if we arrive and your area is not suitable for installation.

We reserve the right to refuse delivery on arrival if any of these terms aren't met.

Security Deposit/Damages

In addition to the fees listed in Section 2, Renter shall pay a refundable damages deposit of £50.00 for Hot Tub Hire, £60.00 for Party Tents | Foam party hires or Venue Hires or £100.00 for Cinema hire at the time this Agreement is signed. This is completely refundable upon collection of the equipment providing no Damages done, please allow 72hrs for the refund to be processed. Lay-z-days Event's may use the deposit to cover any amounts due under this Agreement or towards the cost of pursuing small claims court fees if the renter does not willingly pay for damages or theft.

Any damages caused by gross miss-use are not covered by the £50/£60/£100 damages deposit. You will be billed accordingly i.e. a punctured or ripped hot tub liner will be billed at £300/ Theft billed at the cost of replacement. If the customer does not pay for damage willingly then we will pursue the lost moneys in a small claims court and if it has to lead to this stage then we will also claim for lost hire time.

If we arrive to deliver your Equipment at the agreed time and no one is available to receive delivery, then we will try to rearrange delivery subject to extra fuel costs if necessary. Normally we will give you a morning or afternoon delivery slot allocated 3-5 days prior to hire date. Lay-z-day events cannot be held liable for delayed delivery times due to issues beyond our control

We reserve the right to hold on to your damages deposit for 72 hrs after collection of equipment, this being- if we need time to inspect the equipment to assess damages.

Cleaning Charge.

If we arrive to collect the equipment and it appears to be in a very dirty condition you will incur a £50.00 Cleaning charge. You MUST NOT Enter the Hot tub if you have a fake tan under any circumstances. Please be mindful of items you add to the hot tub such as toys or costumes that may be colour dyed and caused staining TO the hot tub.

Payment

All payments are made on the day of hire either cash /PayPal or bank transfer. If We are hiring to a venue or corporate event - Full payment must be made 48hrs prior to your hire date. We prefer any damages deposit in cash so we have it to hand to give back to you after your hire.

Late Payment. If Renter fails to Pay Their Remaining Balance stated in this agreement within 2 hours from set up, we are within our rights to remove the equipment without any notice, Renter shall then be liable to pay an additional surcharge of £60.00 for late payments or liable to pay the £60 fee for non-payment if we have to remove the equipment.

Location of Equipment. During the Term, Equipment shall be located at SPECIFY:

Care of Equipment.

Equipment can only be used in a careful and proper manner and shall not be used in any way that is inconsistent with Lay-z-days instructions or manuals.

Repair and Alterations.

The costs of all repairs made during the Term shall be paid by Renter, including but not limited to labour, material, parts and other items. Equipment shall not be serviced or repaired and parts and accessories shall not be replaced without Lay-z-days Event's prior consent.

If we arrive, and feel the equipment/gazebo is not safe to set up we will not set up, in high winds in some circumstances we may refuse to put on gazebo side panels as your safety must come first, no advance notice on our behalf is required as this really depends on the set up area and the day of hire wind speed and is upon our discretion.

Insurance

Lay-z-days Event's has 5 million pound cover of liability insurance, covering you in the unlikely event of injury caused from an electrical fault. Customers should note that all tubs and equipment is PAT tested annually, complete with RCD if required.

Lay-z-days Event's, will not be held liable for any damage, accidents, injuries or death caused by misuse of our Hot tubs/venue equipment/ Party Tents/Foam party or Cinema Hires etc and any other equipment, this includes falling over on wet surfaces or falling in or out of the hot tub or tripping over wires etc. ALL Person that suffers with epilepsy, seizures, pregnant or a medical condition SHOULD NOT use any hot tubs unsupervised or party tents with Disco lighting/UV lighting or that contains class 3b lasers



ALL OUR PARTY TENTS (Excluding Gender reveal) CONTAIN CLASS 3B LASERS AND/OR ULTRAVIOLET LIGHTING. IF BOOKING A PARTY TENT YOU MUST NOT CURRENTLY HAVE A MEDICAL CONDION THAT MAYBE AFFECTED BY ENTERING THE PARTY TENT ROOM CONTAINING CLASS 3B LASERS OR ULTRAVIOLET LIGHTING. IF YOU SUFFER FROM EPILEPSY OR HISTORY OF SEZURES OR ARE PREGNANT WE DO NOT RECOMMEND BOOKING OUR PARTY TENTS. WE RECOMMEND IT BE AT THE PARENTS DISCRTION IF UNDER 16S ARE TO USE OUR PARTY TENTS CONTAINING LASERS. ALL CLIENTS HIRING OUR TENTS DO SO AT THEIR OWN RISK.

We will not be held responsible for any accident, injury or death caused by misuse of alcohol or drugs whilst using our Equipment. We highly recommend you DO NOT use a hot tub on your own. We also recommend consulting your GP before hiring our hot tubs or equipment if you have any medical condition or are pregnant. Again we will not be held responsible for any accident, injury, loss of wages or death in any circumstances.

We will not be held responsible for any equipment left out in unsupervised, i.e. party tent or Cinema Hire equipment. All electrical items must be brought in doors at night and in adverse weather conditions, unless stated by Lay-z-days Event's that the items are waterproof or suitable to left outdoors. The renter is responsible for any damages to equipment caused by leaving items out in the rain and will be billed accordingly for replacement equipment if items are damaged, we do not accept any responsibility for any personal injury to yourself or guests caused by electrical shock if trying to operate or use our equipment in the rain not deemed waterproof.

LICENCING

We Are a Equipment hire only company, any films we provide are solely for private individual use only- provided free of charge. If you require licensing for your event this can be done with a company called Film Bank, for certain Public event's you may require a premises license & STSL License, we do not accept any responsibility if you hire our equipment and you do not comply to the law by obtaining any licensing for your events, This is solely the person signing this agreement responsibility to obtain licence.

SAFETY

Our Commercial Gazebos are suitable for bad weather conditions, however in extreme adverse weather conditions please contact Lay-z-days immediately via our direct phone numbers provided to you during your hire.

We do not accept any responsibility when hiring our popcorn machine for personal injury caused by hot popcorn kettle, this gets considerably hot, all renters must take care and only let an adult operate the popcorn machine, not under any circumstances should Adults, children or vulnerable adults be near the popcorn machine whilst the doors are open, we do not take any responsibility for any damages caused by fire hazard in the event the popcorn machine left on unattended. Renters use all equipment at their own risk and must clean the equipment after use, Our popcorn machine is pat tested annually.

We do not accept any responsibility for any personal injury caused by allergies when using the popcorn seeds and seasoning we provide or any other food products we may provide with any packages. All items include full list of ingredient, or allergy information. It's the hirers responsibility to check items are suitable for consumption.

When using our smoke machine, we do not allow this machine to be used in a room where children under the age of 18 are present (this is upon parental discretion) or any persons that are pregnant, the smoke machine must only be used for adults and all renters must seek medical advice if they suffer with any health issues. This product must be used in a safe manner in several intervals not on constantly.

Foam solution can be irratating to the skin and eyes, please do
not enter this party area if you suffer from skin problems.

Should you notice a rash after entering, please rinse
thoroughly with cold water.

DO NOT let the solution into your eyes and do NOT swallow
under any circumstances.

This company or management accept NO LIABILITY for any loss

FOAM PARTY SAFETY RULES MUST BE ADHERED TO AT ALL TIMES

-No glass to be used at the area where foam machine or bubble machine used

·Barriers to be used to keep customers away from the foam machine

·Safety signs to be used around your venue

·First Aid box present on site at all times

·Larger events must have security or stewards to provide crowd safety

Wet floor signs to be displayed at all exits and entrances

·NO Persons under the age of 5 years old or disabled persons are permitted to entering the foam unsupervised, entry is only upon the parental/guardian discretion. All persons entering the foam – Enter at own risk. Foam solution can cause rash's in some children especially young children, everyone's skin is different– so this rule is there to make sure your children are kept safe at all times– If parents allow their child to enter the foam Please be sure to shower after entry. We encourage customers to take advantage of our free sprinkler shower option for outdoor events.

·Please have towels and change of clothing on hand– you will get wet

·The overnight foam cannon machine does not come with an operator.

·A parent/guardian must supervise all children under the age of 18.

·Our overnight foam machine has an emergency STOP button; this button is located on the parental remote that operates the foam cannon. This will stop the cannon immediately.

·Although our foam solution is hypoallergenic, certified dermatologist approved 100% organic, non toxic & environmentally friendly, all foam solutions are still classed as an irritant; therefore all persons entering the foam must rinse afterwards and enter the foam at their own risk– parental consent needed for under 18s.

·Lay-z-days are proud to mention– we have never had an event where any customer's have ever had rashes or injuries due to our foam parties or foam solution we use. We continue to maintain a high standard service.

·We recommend Children MUST wear goggles at all times when entering the foam (although personal choice)

·Old clothes to be worn as foam can cause staining although very rare (not something which has ever happened to any of our customers as of yet)

·Foam parties on Grass can get messy where mud is present- we take no responsibility for any items of clothing or shoes that are damaged whilst using our equipment. Flooring options available.

·No electrical items to be used within at least 10m of the foam unless of course waterproof or extension cables are in weatherproof box.

·Pregnant ladies that are opting for gender reveal- must consult with their doctor prior to booking a foam party, pregnant ladies MUST Not enter the foam with direct skin contact – waterproof trousers can be worn whilst having photos in the foam – its important we keep both you and your baby safe under all circumstances- Pregnant ladies enter the foam at their own risk.

·Same rules listed above apply for using any of our commercial bubble machines.

When booking Lay-z-days for your event, you do so at your own risk, all safety measures are put in place to reduce the risk of injury or damage to surroundings, our machine is Pat tested annually, COSHH reports are on our website and you can also down load our chemical safety data sheets if needed. If in the unlikely event of injury or damage to venue or surroundings, Lay-z-days will not be liable for this as mentioned in this disclaimer.

Chemicals.

Your health is of up most importance to us whilst hiring our hot tubs and all of our tubs are thoroughly cleaned at our base before each new hire period, all hot tubs are fully inspected, fully sanitised and flushed with bio film remover and any other equipment sanitised prior to hire. We bring enough chemicals with us for your hire period .We add the chemicals to start you off and show you how to add more and also provide tutorial videos.

We do not take any responsibility for any skin reactions/rashes or any health issue etc you may incur whilst using the hot tub due to the chemicals used, you are required to add chemicals as instructed and must wear the PPE gloves/ mask/ goggles provided, we do not take any responsibility for any chemicals you add to the spa and you must test your hot tub water twice daily and record your readings in the water testing chart provided.

Damage to Your Property.

Lay-z-days Event's will not be held responsible for any damage to your property through hiring any of our Hot Tubs or other Equipment, this includes any water damage or weight damage to structures as a result of the hot tubs or other equipment location. It is the customer's full responsibility to make sure the area where the hot tub or equipment is going to be placed is suitable and will not cause any damage. The filled weight of a Hot tub est (1600kg) on decking need to be taken into account as do the amount of water that will be displaced on the floor. We will not accept responsibility to damage to any part of your property during the delivery or hire period/process. The hot tubs & equipment are heavy and large and it is the customer's responsibility to ensure there's adequate room. We also take no responsibility for any water damage to your property caused by the hose pipe or injury to you or your guests, it's at the customers own risk if you wish to use this item. We reserve the right to refuse delivery if our terms and conditions are not met.

Venue Safety

Lay-z-days Event's accepts no liability for any damage to your venue or surroundings, every effort has been made to limit any risk of injury or damage.

Lay-z-days also accepts no responsibility for any injury sustained by using any of our equipment such as lasers, disco light, UV lighting, bar cocktail accessories/ mixer set, backdrop stands etc

If there are children under the age of 18 full parental consent must be given prior to entering any of our event rooms that we have set up with class 3b lasers or ultraviolet lighting present- there will always be safety signs displayed.

If hiring our fog machine (water based) please be mindful that fog machines can potentially affect smoke alarms in the venue. Lay-z-days accept no liability for damage caused by using our fog machines- including any costs sustained to the venue for smoke alarm sprinklers going off in the venue or any costs incurred from the venue smoke alarms going off or in the surrounding areas. Please be sure if you are an outside events organiser hiring our equipment at a venue that you are sure to check with the Venue requirements regarding fog machines. Clients hiring our fog machine do so at their own risk and take full responsibility including covering any costs incurred for damages relating to smoke alarms or fire sprinklers in a venue.

.Again We do not recommend under 18s to enter a venue where fog machines are present parental consent must be confirmed.

Backdrops are installed correctly by our team with heavy duty telescopic stands, we accept no liability for any persons that fall/ trips into them, full venue risk assessment will be made prior to any event commencing.

Our backdrops are not flame retardant – if you need our drapes to be flame retardant we now have an option in house for this which compiles to **British standard law B.S.5867 PT2 TYPE B certified to accredited laboratory**– please contact us for more information prior to your event. All our electrical equipment is pat tested annually

Cancellations.

Please try to give us advanced 7 days notice if you would like to cancel hire however booking deposits are non- refundable.

Restrictions on Use.

Renter shall not:

- a) permit the Equipment to be used by any person who is not authorized to use such Equipment;
- b) operate or use the Equipment or permit it to be operated or used in violation of law;
- c) operate or use the Equipment or permit it to be operated or used to commit a violation of law; and/or
- d) operate, use, maintain or store the Equipment in a manner likely to cause damage to the Equipment.

1. **Loss or Damage.** Renter shall alert Lay-z-days Event's to any damage to the Equipment. Renter shall be responsible for any loss or damage to Equipment and loss of use, diminution of the Equipment's value caused by damage to it or repair to it and missing equipment.
2. **Condition of Equipment.** Renter acknowledges that Renter has examined the Equipment and that it is in good condition except as otherwise specified by Lay-z-days Event's
3. **Return of Equipment.** Renter shall return Equipment on the date specified in Section 1 in the same condition as Renter received it. Renter shall return the Equipment to the same agreed return location. If Equipment is not returned on said date, Lay-z-days Event's reserves the right to take any action necessary to regain possession of the Equipment.
4. **Termination.** This Agreement shall terminate on the date specified in Section 1. Lay-z-days reserve the right to terminate this Agreement earlier than hire upon notice to Renter.

Indemnification and Liability.

Renter shall defend and not hold Lay-z-days Event's liable for any claim, demand, cause of action, loss or liability (including attorney's fees and expenses of litigation) for any property damage or personal injury arising from Renter's use of Equipment by any cause. Lay-z-days Event's does not take any responsibility for any cases of Death to you or anyone else using our equipment / we do not take any responsibility for damages to your property under any circumstance. The provisions of this Article shall survive the termination of this Agreement with respect to any claims or liability accruing before such termination. IN NO EVENT SHALL Lay-z-days BE LIABLE FOR ANY INDIRECT, SPECIAL OR CONSEQUENTIAL LOSS OR DAMAGES ARISING FROM RENTER'S USE OF EQUIPMENT, and EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES.

Ownership.

Lay-z-days Event's shall at all times retain ownership and title to the Equipment. Renter shall immediately notify Owner in the event Equipment is stolen or damaged.

Severability.

In the event any provision of this Agreement is held by a court or other tribunal of competent jurisdiction to be unenforceable, that provision will be enforced to the maximum extent permissible under applicable law, and the other provisions of this Agreement will remain in full force and effect. The parties further agree that in the event such provision is an essential part of this Agreement, they will begin negotiations for a suitable replacement provision.

Renter acknowledges receipt of a copy of this Agreement and acknowledges having read and understood the foregoing.

Included in our Hire agreement

Please see our Hot Tub do's & Don'ts

The customer must agree to the following conditions set out by Lay-z-days Hot Tub Hire or the hire will be terminated and we will not be held responsible for non-compliance.

DO NOT allow children of any age to play in or around the hot tub unsupervised – risk of drowning.

DO NOT have any mains electrical appliances near the hot tub, please ensure that any electrical appliances including lights/music systems etc are away from the hot tub to avoid any risk of electrocution.

DO NOT use the hot tub if you have taken any prescription medication that could make you drowsy or if you have taken any recreational drugs that could impair your judgement

DO NOT use any glasses/bottles in the hot tub, please only use plastic

DO NOT do not dive into the hot tub

DO NOT add anything to the water including bubble baths/detergents/dyes etc.

DO NOT USE any face paints, party poppers, coloured streamers, candles or silly string to be used either on or near the hot tub.

DO NOT No smoking or barbecues near the hot tub or equipment.

DO NOT have any pets on or near the hot tub, no toys or sharp objects in or by the hot tub.

DO NOT use the hot tub at all whilst the chlorine tab chemical floater is in the hot tub please ensure the chemical floater tab is NOT left in the hot tub when the spa is emptying otherwise this causes staining to the spa.

DO NOT use the hot tub if you are feeling unwell , any sick or soiling must be cleaned otherwise you will incur a cleaning charge.

DO NOT have any shoes, glasses, jewellery, badges they **MUST** be removed before using the hot tub.

DO NOT allow anyone in the hot tub during inflation or deflation as this may damage the spa.

DO NOT Children and the elderly should not use the **HOT TUB** with very hot temperatures; we do not take any responsibility for this.

DO NOT USE the hot tub outside with temperatures below 4 degrees

In the event of heavy rain or severe weather conditions, please make sure the **HOT TUB**

Is switched off and any power supply is in the closed weatherproof box or dry area

DO NOT use the hot tub in any way that could damage it. This includes sitting on the cover, standing or sitting on any of the motor housing or standing or sitting on any of the filter covers. Any breakages will be charged to the hirer and failure to compensate Lay-z-days Hot Tub Hire will result in a claim being made to the Small Claims Court.

PLEASE DO Follow the instructions that are provided (you will also be shown at delivery) on how to maintain the water and keep it clear for pleasant bathing. If you do not follow our instructions and the water becomes dirty which in turn clogs up the heater/filter pump then we will not be held responsible for the hot tub cutting out and not working correctly and therefore you will not be entitled to any refunds or discounts off your hire. If we are available and only if we are available, we will come out to rectify the problem and a fuel charge will be chargeable.

PLEASE DO take a shower before using the hot tub – it's not a bath!!

PLEASE DO wash or wipe your feet before entering the hot tub to prevent dirt/debris getting into the water.

PLEASE DO clean the filter after the end of each day and add chemicals accordingly as instructed to maintain your water quality and to maintain hygiene levels.

PLEASE DO keep the water level topped up as instructed. Failure to do so can result in failure of the hot tub.

PLEASE DO ensure the thermal cover is put on the hot tub when it isn't being used.

please remember its a hot tub not a swimming pool so please take care!

PLEASE DO READ THE FULL INSTRUCTIONS.

PARTY BOX HIRES – SHIPPED TO YOU

DAMAGES DEPOSIT & TERMS

BEFORE YOUR PARTY BOX IS DISPATCHED, WE WILL SEND YOU A SECURE PAYMENT LINK TO PAY £50 DAMAGES DEPOSIT. IF YOU WOULD PREFER TO PAY THIS VIA BACS YOU CAN ALSO DO THIS. DAMAGES DEPOSITS ARE FULLY REFUNDABLE WITHIN 5 DAYS OF RECEIVING THE DECOR BOX BACK TO US PROVIDING NO DAMAGES DONE.

IF THE DECOR IS DAMAGED IN ANY WAY, RIPPED, STAINED ETC YOU WILL LOSE YOUR DEPOSIT. IF YOU FAIL TO RETURN THE DECOR BOX TO US WITHIN THE TIME ALLOCATED (7 DAYS OF YOUR EVENT) THIS WILL INCUR A LATE PAYMENT FEE OF £35 WHICH WILL BE TAKEN OUT OF YOUR DAMAGES DEPOSIT.

WE CAN SEE WHEN THE BOX HAS BEEN SENT BACK TO US WITH THE SECURE PRE-PAID TRACKING LABEL INCLUDED

IF YOU FAIL TO RETURN THE DECOR BACK TO US ENTIRELY WE WILL PURSUE A CLAIM MADE AGAINST YOU IN SMALL CLAIMS COURT.

ONCE YOU HAVE BOOKED ONLINE PLEASE FORWARD US YOUR PHOTO IDENTIFICATION & IF YOUR PHOTO IDENTIFICATION DOES NOT DISPLAY YOUR CURRENT RESIDENTIAL ADDRESS PLEASE PROVIDE A DOCUMENT WITH PROOF OF RESIDENTIAL ADDRESS, A UTILITY BILL ETC. WE CAN NOT DISPATCH YOUR DECOR BOX WITHOUT THIS – IF THIS IS NOT PROVIDED YOUR DECOR BOX WILL BE CANCELLED. DUE TO HIRING OUR DECOR YOU MAY NOTICE MINOR TINY HOLES WHERE THE DECOR HAS PREVIOUSLY BEEN HIRED– CAN NOT BE NOTICED UNDER THE UV LIGHT.
