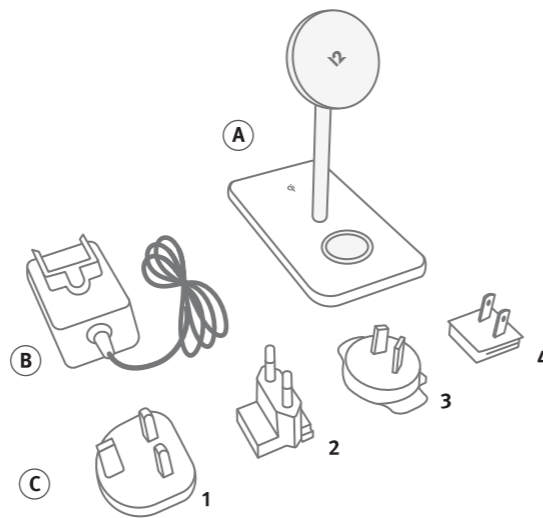

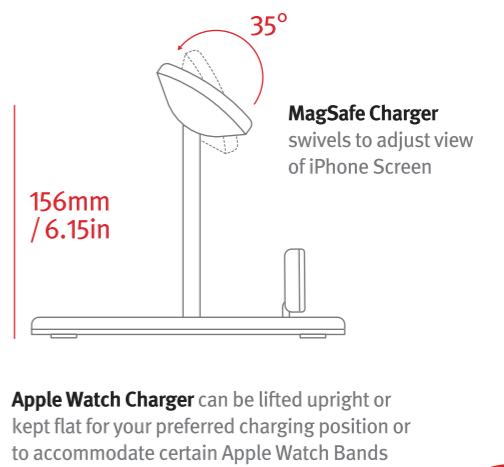
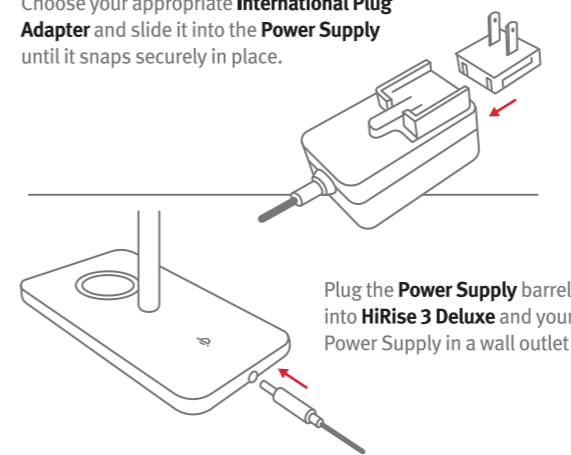

Choose your appropriate **International Plug Adapter** and slide it into the **Power Supply** until it snaps securely in place.

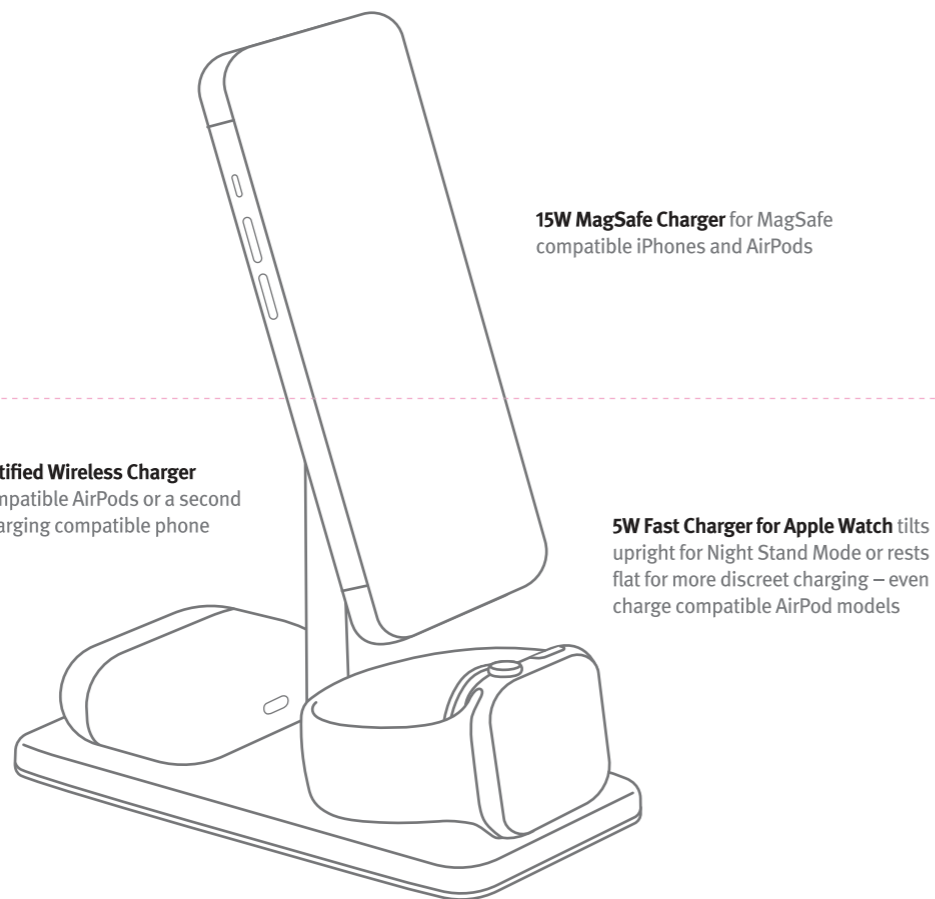

Charging your Devices
