Privacy Policy

Welcome to our Privacy Policy

-- Your privacy is critically important to us.

The Wine List is located at: Walmer Castle Court, 102 Peckham Road, London.

It is The Wine List's policy to respect your privacy regarding any information we may collect while operating our website. This Privacy Policy applies to <https://thewinelist.net> (hereinafter, "us", "we", or "https://thewinelist.net"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

- Website Visitors

Like most website operators, The Wine List collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. The Wine List's purpose in collecting non-personally identifying information is to better understand how The Wine List's visitors use its website. From time to time, The Wine List may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

The Wine List also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users. The Wine List only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

- Gathering of Personally-Identifying Information

Certain visitors to The Wine List's websites choose to interact with The Wine List in ways that require The Wine List to gather personally-identifying information. The amount and type of information that The Wine List gathers depends on the nature of the interaction. For example, we ask visitors who sign up for a subscription at <https://thewinelist.net> to provide a username and email address.

- Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

- Aggregated Statistics

The Wine List may collect statistics about the behavior of visitors to its website. The Wine List may display this information publicly or provide it to others. However, The Wine List does not disclose your personally-identifying information.

- Cookies

To enrich and perfect your online experience, The Wine List uses "Cookies", similar technologies and services provided by others to display personalized content, appropriate advertising and store your preferences on your computer.

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. The Wine List uses cookies to help The Wine List identify and track visitors, their usage of <https://thewinelist.net>, and their website access preferences. The Wine List visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using The Wine List's websites, with the drawback that certain features of The Wine List's websites may not function properly without the aid of cookies.

By continuing to navigate our website without changing your cookie settings, you hereby acknowledge and agree to The Wine List's use of cookies.

- E-commerce

Those who engage in transactions with The Wine List – by purchasing The Wine List's services or products, are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, The Wine List collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with The Wine List. The Wine List does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Although most changes are likely to be minor, The Wine List may change its Privacy Policy from time to time, and in The Wine List's sole discretion. The Wine List encourages visitors to frequently check this page
