## **Application for Exhibiting Membership**

Craft NSW is the trading arm of the Society of Arts and Crafts of NSW and is completely member operated.

The Society has a long history, tradition and philosophy aimed at keeping handcrafts alive. It is not just an organisation that offers work for sale: it is an institution that encourages artists to:

- maintain the high standards as set out in the selection criteria and in their creative endeavours
- support the ethics of the Society when on duty by interacting with visitors in a polite and informative manner, to provide them with an awareness and appreciation of Australian craft and design.

When you become a member of The Society, you are continuing this heritage of excellent craft, volunteering your talents to keep it viable for future artisans and aspirants. This is your venue for exhibitions, for selling online and encouraging emerging craft makers.

We at Craft NSW are all craft makers but with expertise and talents in various areas. The Society needs volunteers who can continue planning exhibitions, volunteers who can replenish Instagram and Facebook, keep the Online Store and the website operating and interesting to consumers, volunteers in display teams, design teams and to participate in roles of newsletter editor, treasurer, secretary and president to name a few.

Unless you have been invited to be a guest exhibitor at one of our exhibitions, in which case your work will be considered by the Selection Panel during the exhibition, your application for exhibiting membership will be based on SIX (6) items of craft submitted for consideration by our Selection Panel. It is also desirable that your application is supported by 6 images of your past work.

The work must be original in design, handmade by the applicant and show a superior skill in finish and presentation. The work submitted with this application must be the work that is intended to be displayed and sold at exhibitions and online. It is not acceptable to submit work that is intended as exhibition work only and is not available for sale.

Please note the following, once accepted:

All work must be new, recent, priced and labelled according to Craft NSW requirements.

- \* All members are able to participate in any exhibition organised by Craft NSW for \$60 per exhibition unless the exhibition is restricted to a particular craft.
- \* Members are asked to volunteer their services for duty at our exhibitions, usually 1 or 2 days depending in the length of the exhibition.
- \* When we have a permanent gallery, members would be asked to do duty 2 days per month.
- \* Members may nominate themselves for any vacant position and are eligible to vote at the AGM.
- \* Members are entitled to participate in our Online Store and asked to provide high quality images and description of each work to be uploaded to the Online gallery. Please note that prices of your work for Online and Exhibitions remain the same though Craft NSW receives varying commissions according to the exhibition gallery's rulings
- \* Members receive a monthly newsletter, monthly board meeting minutes and Telopea magazine.

## Fees

- New members pay \$80 one off joining fee and \$60 annual membership.
- If you join in October, November or December you will be covered for the following year. Otherwise, membership is due on January 1 each year. Please pay by January 31 each year.
- You will be asked to pay fees once your application has been accepted.
- \$60 exhibition fee is payable 4 weeks prior to each exhibition when confirmation of participation is due.

#### **Commission** is payable on all sales.

- Online commission. The Society will take \$30 in every \$100 of sales This is a commission of 27.27% + 10% GST on commission which the Society remits to the ATO.
- **Exhibition commission** The Society will take \$40 in every \$100 of sales. This is a commission of 36.36% plus 10% GST on commission which the Society remits to the ATO
- When the artist is registered for GST, commission is charged on the consigned sales price less 1/11 (the assumed retail GST component) The retail GST component is repaid to the artist who is then responsible for remitting it to the ATO

Please do not submit payment of fees with your application form

You will be notified by email as to the outcome of your application within approximately 6 weeks of your lodgement date.
