## Application for Exhibiting Membership

The Society encourages craft workers of NSW to design and create work, using motif, material and social commentary drawn from the Australian experience and Australia's cultural diversity.

Craft NSW, the gallery of the Society is completely member operated. It is an expectation for exhibiting members who live within and including the area spanning the environs of: Campbelltown-Sydney-Wollongong-Springwood and Gosford, to participate in the duty roster, currently 24 days per year.

The Society has a long history, tradition and philosophy aimed to keep handcrafts alive. It is not just an organisation that offers work for sale it is an institution that encourages artists to

- continually maintain the high standards as set out in the selection criteria, in their creative endeavours for the length of membership.
- support the ethics of the Society when on duty in the Gallery by interacting with visitors in a polite and informative manner, to impart to them an enjoyable experience and a greater awareness and appreciation of Australian Craft and design. Your application for exhibiting membership will be based on SIX (6) items of craft submitted for consideration by our Selection Panel. It is also desirable that your application is supported by 6 images of your past work.

If your work is accepted there is a six months waiting period before further work submissions can be made for acceptance into your existing or a new category.

The work must be original in design, handmade by the applicant and show a superior skill in finish and presentation. The work submitted with this application must be the work that is intended to be displayed and sold in the Gallery. It is not acceptable to submit work that is intended as exhibition work only.

Please note the following, once accepted:

All work must be new, recent, priced and labelled according to Craft NSW requirements. No personal contact information is permitted on the work.

Commission is payable on all sales.

The Society will take a commission of 30% for members completing 2 days gallery duty per month, 36.5% for members completing 1 day gallery duty per month and 43% for non-duty members, plus 10% GST on that commission (which the Society remits to the ATO).

Where the member is registered for GST, commission is charged on the consigned sales price less 1/11th (the assumed retail GST component). This retail GST component is repaid to the member, who is then responsible for remitting it to the ATO. The Board of The Society, with a period of one month's notice, reserves the right to change the commission rate.
