

Terms & Conditions

Australia's Overlanding Photo Competition 2024

1. Name of the entity running Australia's Overland Photograph Competition 2024 (the Competition)

The entity is Engineered Touring Solutions Pty Ltd t/a RacksBrax (the Promoter) (ABN 37 628 703 766) of PO Box 7081 of East Brisbane QLD 4169, Australia.

2. Drawing dates and winner selection

The competition commences at 12:00am midnight AEST on 29/03/2024 and ends at 11:59pm AEST on 30/04/2024 ("Promotion Period"). The time of entry will in each case be the time the online entry is received by the RacksBrax and recorded in its competition email address.

The winner will be selected by a panel of four (4) judges from a panel created by RacksBrax; one representative from each of the following companies: Salt Design, Thule (GoActive Outdoors), Darche and the Royal Flying Doctor Service (Queensland Section) (RFDS). The Winner and one (1) Runner-Up will be determined by the panel created by RacksBrax.

3. Eligibility requirements for players to participate

Entry is only open to residents of Australia who are 18 years and over who upload photographs they own to RacksBrax' competition address: <https://www.racksbrax.com/pages/competitions> . Employees and their immediate families of RacksBrax, and their agencies are ineligible to enter. RacksBrax Dealers are eligible to enter. To enter, entrants must, during the Promotion Period:

- Send a photograph they own the rights to;
- Upload that photograph to RacksBrax' competition landing page as follows: <https://www.racksbrax.com/pages/competitions>
- The photograph must best encapsulate the theme: Australia's Overland Photograph Competition 2024 ... who is Australia's best overland photographer?
- The photograph must be in .jpg format. High resolution: ideally 300dpi.
- Image size to suit up to an A1 poster (594mm x 841mm).
- Note: poor/low resolution or phone camera images will be disqualified.

By sending their photograph to RacksBrax, the entrant grants permission and a non-exclusive license for RacksBrax and other competition sponsors to use their photograph for marketing activities related to RacksBrax and other competition sponsors with appropriate credit given and no compensation expected in return.

Entries will be deemed accepted at the time of transmission when the email with photograph is received by RacksBrax' competition email address. In any dispute relating to whether entries have been received or not, will be determined by the Promoter, whose decision is final. Any entry that contains content that RacksBrax, in its sole discretion, considers to be incomplete, inaccurate, underage, erroneous, ineligible, offensive, misleading, inappropriate or incomprehensible will be deemed invalid, as well as any entry that RacksBrax, in its sole discretion, considers to infringe any intellectual property rights or other rights of any person, corporation or entity. RacksBrax accepts no responsibility for late, lost or misdirected entries.

4. Maximum number of entries per participant

Each competition participant is allowed as many entries as they would like.

5. Manner of resolving disputes

Prizes are not transferrable and are not redeemable for cash. RacksBrax assumes no responsibility for any failure to receive an entry or for inaccurate information or for any loss, damage or injury as a result of technical or telecommunications problems, including security breaches. If such problems arise, then RacksBrax may (where necessary with the approval of the relevant authority) modify, cancel, terminate or suspend the Competition.

6. Age limit of participants

All entrants into the Competition must be over the age of 18.

7. Retail value of each of the prizes
