COMMUNITY OUTREACH/SPAY & NEUTER PROGRAM - AFRP'S COMMUNITY OUTREACH SPAY/NEUTER VOUCHER PROGRAM PROVIDES LOW AND NO COST SPAY/NEUTER SERVICES FOR SMALL DOGS AND CATS FOR THE PUBLIC, FOCUSING ON TARGETED AREAS IN OUR COMMUNITY, THAT HAVE THE HIGHEST RATE OF SHELTER ANIMAL INTAKES. WE ALSO HAVE A SPAY-NEUTER-RELEASE PROGRAM FOR FERAL CATS. OUR GOAL WITH THESE TARGETED PROGRAMS IS TO REDUCE THE NUMBERS OF ANIMALS BEING BORN OR FOUND ROAMING FROM ENTERING INTO THE SHELTER SYSTEM BY PROVIDING ACCESS TO AFFORDABLE SPAY NEUTER SERVICES THEREFORE MAKING IT A DESIRABLE OPTION FOR THE COMMUNITY TO HELP REDUCE THE NUMBER OF UNWANTED ANIMALS NEEDING ASSISTANCE. THESE PROGRAMS HAVE SPAYED, NEUTERED AND CARED FOR OVER 380 CATS AND DOGS THIS SHORT YEAR.

ANIMAL FRIENDS RESCUE PROJECT (AFRP) IS A SAFETY NET FOR THE MOST AT RISK ANIMALS IN OUR LOCAL SHELTERS. THESE ANIMALS ARE TYPICALLY TOO YOUNG, TOO OLD, INJURED, ABUSED, SHY AND OVERLOOKED DOGS AND CATS THAT DO NOT DO WELL IN THE SHELTER ENVIRONMENT. AFRP RESCUED AND FOUND HOMES FOR 263 DOGS, CATS AND RABBITS DURING THE 2021 SHORT YEAR WITH THE HELP OF OVER 600 VOLUNTEERS. OUR ADOPTION CENTER IN PACIFIC GROVE CONTINUES TO BE A SUCCESSFUL LOCATION FOR FINDING NEW HOMES FOR DOGS AND CATS. IN ADDITION TO OUR MAIN CENTER WE HAVE PARTNERSHIPS WITH PET FOOD EXPRESS, AND PETCO TO HOST SATELLITE CAT ADOPTION CENTERS.

ANIMAL FRIENDS LIFELINK TRANSPORTATION PROGRAM SAVES THE LIVES OF DOGS THAT WOULD OTHERWISE HAVE BEEN EUTHANIZED.
