

LIGHTENING LIFT® FORTE TREATMENT



1. CLEANSE

Apply **AGELESS TOTAL FACIAL CLEANSER** and cleanse the skin for 1-2 minutes. Remove with tepid water and sponges.

2. PREP

Saturate rough gauze with **DEGREASING PREP SOLUTION**. Squeeze out excess solution. Using firm pressure, swipe gauze in both horizontal and vertical directions over the entire area to be treated.

3. PEEL

Measure 1/8 oz. - 1/4 oz. of **LIGHTENING LIFT** into a medicine cup. Apply peel with an **I SWAB** in a circular motion beginning at forehead, moving to right cheek, left cheek, nose and perioral area. Massage peel for 1-3 minutes. Peel may be left on the skin an additional 1-7 minutes (gradually increasing with each treatment). Remove thoroughly with cool water and sponges until client feels **ZERO** activity.

ELEVATE **MASQUE**
For clients who prefer less visible exfoliation post peel, apply **VITAL C HYDRATING ENZYME MASQUE** with an **IMAGE MASQUE BRUSH**. Add 1 full dropper of **I ENHANCER** of choice according to specific skin needs. Leave on skin for 5 minutes. Remove with tepid water and sponges.
(Optional: Perform arm and hand massage with **VITAL C HYDRATING HAND AND BODY LOTION**).

4. ENHANCE

Customize by combining 1 full dropper of chosen **I ENHANCE** based on client's skin needs with **ILUMA INTENSE BRIGHTENING SERUM** and apply to entire treated area.

ELEVATE **EYE REPAIR**
Apply **VITAL C HYDRATING EYE RECOVERY GEL** to orbital area.

5. PROTECT

Apply a generous amount of **PREVENTION+ ULTIMATE PROTECTION MOISTURIZER SPF 50** to entire treated area.

ELEVATE **PLUMP**
Apply **ORMEDIC BALANCING LIP ENHANCEMENT COMPLEX** to entire lip area.

FLAWLESS FINISH
Apply **I CONCEAL** using **FOUNDATION BRUSH** to create a flawless finish.

HEAL: Provide **IMAGE POST TREATMENT KIT** to client and review post treatment care.

YANA: Offer the client a complimentary sample of **YANA™ DAILY COLLAGEN SHOTS**.

INDICATIONS: Pigmentation, uneven skin tone, post-inflammatory hyperpigmentation
