

PR10.0-V FLUSH MOUNT AIR CLEANER

600 – 1,200 CFM - 1 unit covers approximately 6,000 cubic feet. 3-filter system includes pre-filtration, 6 inches of HEPA media and 18 pounds of carbon.



In addition to providing a **95% high-efficiency HEPA filter media**, the PR10.0-V Commercial Smoke Eater utilizes **18 pounds of activated carbon in a V-Bank housing**. The PR10.0-V is an excellent choice when the need to control tobacco smells is required - **including cigar & cigarette odors, and marijuana odors**. Carbon can hold many times its weight in odor molecules and will continue to remove smells for up to 1 full year.

The PR10.0-V Air Cleaner is designed to drop into a suspended ceiling. It replaces either (1) 2' x 4' tile or (2) 2' x 2' tiles. **13" of clearance above the drop ceiling is required**. It's recommended that the ceiling height does not exceed 10 feet. **The weight of the system does not rest on the ceiling grids but is secured above the suspended ceiling to a permanent structure such as a joist or beam**. All filters in the PR10.0V are accessible from the intake grill on the face of the system. **1 unit recommended for every 6,000 cubic feet.**

How does the PR10.0-V work? Three (3) Filter System Provides Excellent Smoke Removal Results. The PR10.0-V Air Cleaning System uses a powerful blower to draw the air from smoke-filled areas. As the air flows through the high-efficiency filter media, 95% of airborne particles & contaminants are removed on each pass. The clean air that is constantly discharged into the area is refreshing and remarkably free of smoke, odors and particles.
