PRIOR TO COVID-19, PEWABIC POTTERY TYPICALLY WELCOMED OVER 50,000 ON-SITE VISITORS EACH YEAR, AND OVER 80,000 VISITORS VIEW THE SOCIETY'S WEBSITE.
