PHILLIPPA'S PTY LTD - CONDITIONS OF SALE FORM

1. DEFINITIONS

In these conditions:-

- 1.1. "Phillippa's" means Phillippa's Pty Ltd ABN 61 427 450 798;
- 1.2. "You" means the person who places an Order, or on whose behalf an Order is placed, for Goods with Phillippa's:
- 1.3. "Goods" means the goods described on the front or in the Order;
- 1.4. "Order" means an order for Goods submitted by You to Phillippa's;
- 1.5. "Invoice" means Phillippa's invoice to You;
- 1.6. "Charges" means the price agreed in writing between the parties or, in the absence of such agreement, the amount calculated under Phillippa's then current price list, plus any freight charges and any tax including a goods and services tax ("GST") levied on a transaction of supply under these conditions.

2. PHILLIPPA'S RIGHT TO REJECT AN ORDER

Phillippa's reserves the right to accept or reject your Order in whole or in part.

3. PAYMENT

- 3.1. You must pay the Charges by direct deposit, cheque, credit card or cash within (7) days from the date of Invoice.
- 3.2. Phillippa's may charge interest on any overdue payment at prevailing bank overdraft rate calculated daily from the due date stipulated until payment.
- 3.3. You may not withhold payment of any monies owing pursuant to an Invoice.
- 3.4. Phillippa's prices represent the exclusive value of the supply for GST purposes and You must pay GST in addition to the stated value unless specifically stated to include GST.
- 3.5. You will be liable for any costs incurred by Phillippa's in retrieving outstanding payments.

4. DELIVERY

Delivery takes place on the date and time the Goods are left by Phillippa's at the address nominated by You as the delivery address.

5. PROPERTY AND RISK

- 5.1. You accept the risk of loss, damage or deterioration of the Goods from the time of delivery.
- 5.2. Phillippa's reserves the following rights, in addition to any other rights or remedies to which it is entitled, until You pay the Charges and any interest owing pursuant to clause 3.2:
 - **5.2.1.** ownership of the Goods;
 - 5.2.2. the right to enter your premises (or the premises of any associated company or your agent where the Goods are held) without liability for trespass or any resulting damage and retake possession of the Goods; and
 - 5.2.3. the right to keep or re-sell Goods repossessed under clause 5.2.2.
- 5.3. If You fail to pay the Charges on the due date, then in addition to any other rights or remedies to which it is entitled, Phillippa's may in its absolute discretion withhold supply and delivery of any further goods.

6. EXCLUSIONS AND LIMITATIONS

- 6.1. Subject to 6.3, Phillippa's excludes from these conditions all conditions and terms implied by statute, general law or custom.
- 6.2. To the extent permitted by law, Phillippa's excludes all liability to You for acts or omissions of Phillippa's, any delay, non-delivery or other failure to supply the Goods or any injury, loss or damage of any kind in tort (including negligence) or contract or otherwise arising out of the Goods on these conditions.
- 6.3. If the Goods are supplied to You as a "consumer" of goods or services within the meaning of "consumer" in the Competition and Consumer Act 2010 as amended or similar state legislation, nothing in these conditions excludes, restricts or modifies any condition, warranty, right or remedy conferred by the Competition and Consumer Act 2010 as amended or similar legislation, except to the extent permitted by law.
- 6.4. If the Goods are goods not ordinarily acquired for personal, domestic or household use or consumption for the purposes of the Competition and Consumer Act 2010 as amended or similar legislation, Phillippa's liability is limited to the supply of the Goods again or payment of the cost of supplying the Goods.
- 6.5. The exclusions in 6.1 and 6.2 extend to loss of profits, business or anticipated savings and other indirect or consequential damage and to economic loss and even if Phillippa's knows they are possible or otherwise foreseeable.

7. PURCHASER'S ACKNOWLEDGEMENT

- 7.1. Despite anything else in these conditions, You acknowledge that:-
 - 7.1.1. Prior to ordering the Goods You satisfied Yourself as to the their suitability for Your purpose; and
 - 7.1.2. Phillippa's has made no warranty or representation about the Goods' quality, fitness for purpose, safety or suitability.

8. USE-BY DATE

- 8.1 Goods must not be sold beyond their 'use-by' or 'best-by' date (where relevant).
- 8.2 If You do not comply with clause 8.1, You must indemnify Phillippa's for any costs or expenses and any loss or damage resulting (directly or indirectly) from the sale or supply by You of such Goods.
- 8.3 Bread may only be sold after the date of delivery if it is clearly marked to show the age of the bread.

9. VARIATIONS

9.1 Phillippa's may vary these conditions from time to time in its absolute discretion and You agree to be bound by such varied conditions provided that You receive at least 14 days written notice of such varied conditions.

10. GENERAL

- 10.1. These conditions are governed and must be construed under the laws of the State of Victoria and Phillippa's and you submit to the exclusive jurisdiction of the Courts of that state,
- 10.2. If a condition or part is unenforceable the unenforceability does not affect any other part of the conditions or any other condition.
- 10.3. Phillippa's is not bound by any waiver, discharge or release of a condition or any agreement which varies these conditions unless it is in writing and signed for Phillippa's by an authorised officer.
- 10.4. If Phillippa's waives a breach of condition the waiver does not operate as a waiver of another breach of the same or any other condition or as a continuing waiver.

- 4. I/we indemnify Phillippa's and Phillippa's employees, servants and agents against all loss, damage, costs and expenses suffered or incurred by Phillippa's as a result of or in connection with any failure by the Customer to comply with its obligations under Phillippa's Conditions of Sale including but not limited to failure to pay any money owing to Phillippa's in accordance with Phillippa's Conditions of Sale.
- 5. I/we acknowledge that this guarantee and indemnity will remain in full force and effect notwithstanding:
 - that Phillippa's may grant time or any other indulgence to the Customer in respect of all or any of the obligations of the Customer under any agreement between the Customer and Phillippa's;
 - that the Customer may avoid liability in respect of all or any of the obligations of the Customer on the grounds of lack of power or defect in execution of any Agreement by any party;
 - (c) that the Customer commits any act of bankruptcy as defined in the Bankruptcy Act 1966 (Cth), makes a scheme or arrangement with creditors, or is placed in receivership, liquidation, administration or any form of insolvency administration; and
