Terms and Conditions

- 1. Sakura Distributors Inc. ("Sakura") may charge the Customer two percent (2%) interest of per month on the Customer's overdue invoices.
- 2. Sakura may charge the Customer an additional fee of \$50.00 for non-sufficient funds (NSF).
- 3. If Sakura does not receive payment from the Customer when payment is due, Sakura may file a lien against the Customer's property with the appropriate government agency.
- 4. Returned goods must be returned to Sakura within thirty (30) days of the original purchase from Sakura and must be in the same condition and packing as when delivered by Sakura to the Customer.
- 5. Sakura may charge the Customer a ten percent (10%) restocking fee on goods returned by the Customer.
- 6. Special orders, smoke alarms and light bulbs, pot light and trims are not returnable.
- 7. Clearance and clear-out items are final sale.
- 8. The Customer shall notify Sakura immediately of any change of name, address, or any other material change of the Customer's information that may affect the Customer's relationship with Sakura.
- 9. Sakura retains beneficial and legal title and ownership of all products until the Customer pays the Customer's account in full to Sakura for the products.
- 10. This Agreement shall not be affected by any change in the name of the Customer, by the acquisition of the Customer's business by a corporation, or by any change whatsoever in the objects, capital structure, the constitution of the Customer, or by the Customer's business being amalgamated.
- 11. The Customer shall provide Sakura the Customer's:
 - a. Business License;
 - b. PST Exemption Certificate:
 - c. CRA Registration; and
 - d. identification or the driver's license of an authorized signatory of the Customer.
