# **Jumpstart 2015**

At Canadian Tire Jumpstart Charities, we understand the importance of play in a child's development, and believe financial barriers should not limit access to this essential building block.


In addition to helping kids stay active, taking part in sports and other forms of organized recreation helps build a foundation of confidence, self-discipline, social skills and teamwork that can make a lasting contribution to success in every aspect of a child's life. And it's fun too.

Jumpstart gets kids in the game by helping families overcome the financial barriers associated with registration, equipment and transportation costs. As a national charity with a local focus, we make sure that the money we raise in a community stays in that community.

Today, Jumpstart has more than 300 Chapters across Canada, made up of volunteers from the Canadian Tire Family of Companies and local community groups. These Community Partners also help Jumpstart Chapters identify kids whose families need funding assistance. Our largest single supporter is Canadian Tire Corporation (CTC), which funds Jumpstart's general administrative expenses. This support allows Jumpstart to allocate 100% of customer donations directly towards helping kids in need.

In addition to direct financial assistance, the entire Canadian Tire Family of Companies provides support to Jumpstart and Jumpstart kids. Every spring during Jumpstart Month, stores across Canada - including Canadian Tire, Mark's, Sport Chek, Atmosphere, National Sports, Sports Experts and Gas+ locations – encourage their customers to donate in-store.

Throughout the year, CTC employees across Canada hold fundraising events at their store, office or in the community. They also volunteer at Jumpstart Games, where children from our local Community Partners are invited to spend a day filled with games, sports and fun. Their commitment and support, along with the support of vendors, partners and customers, is how Jumpstart has been able to get more than one million kids off the sidelines and into the game since 2005.

## "2015 was a year of change and achievement for Jumpstart. It was our best year ever in many ways."

2015 was a turning point for Canadian Tire Jumpstart Charities. We marked our 10th anniversary and extended help and support to our millionth Jumpstart child. We received more than \$23 million in donations, and disbursed almost \$21 million to help 206,097 kids across Canada - the largest number of kids we've ever helped in a single year.

Among our many changes for the year was the move to "outsource" our marketing and fundraising to the great teams throughout Canadian Tire Corporation. Combined with employee engagement from Canadian Tire Corporation and increased brand awareness, we helped more kids than ever before take part in the sports and activities they love so much.

An important driver for participation in 2015, and one of the most exciting events we've ever been involved in, was The Big Play. This groundbreaking program, developed in partnership with the Hockey Canada Foundation, will help get 30,000 kids on the ice by 2017.

Partnership has always been important to Jumpstart. We've also built relationships with a remarkable group of individuals - our Jumpstart Ambassadors. The generous support of athletes like Wayne Gretzky, Connor McDavid, Kyle Lowry, Kaillie Humphries, Jonathan Toews and many others has helped to tell our story, add excitement to our events and make a positive difference in the lives of Jumpstart kids. Another significant transition for Jumpstart in 2015 was the decision of Martha Billes, our Chairman and founder, to pass the torch after 10 extraordinary years. The driving force behind our first decade, Martha's dream was to eliminate financial barriers that keep children from participating in organized sports and recreation. If not for her leadership, there wouldn't be a million kids today, across the country, who got a chance to get in the game thanks to Jumpstart.

The responsibility has been passed to Martha's son, Owen Billes. A long-time Canadian Tire Dealer and Jumpstart supporter, Owen's vision and leadership reaffirm his family's commitment to kids and communities across Canada.

2015 was a year of change and achievement for Jumpstart. It was our best year ever in many ways, and there are so many people who contributed – our Community Partners, employees and customers – I can't thank them enough. 


