Thank you for consigning with Curated, a division of Design with Consignment, LLC. We will make a concerted effort to sell all consigned items, however, Curated cannot and does not guarantee all item(s) will sell. Curated will always attempt to obtain the best possible price for all consigned items. However, resale is a demand-based business, and items tend to sell for their 'fair market' value.

- Our consignment period is 60 days. Our markdown procedure is:
 - Your items will remain at full consignment price for 20 days;
 - After 20 days (day 21), your items will be reduced 15%;
 - After 40 days (day 41), your items will be reduced an additional 15% (total 30%) until the end of the consignment period (60 days).
- Your consignor share:
 - Items within 20 days of the consignment date, you will receive 55% of the consignment price;
 - Items sold after 20 days (day 21) of the consignment date until the end of the consignment period (60 days), you will receive 50% of the consignment price.
- Payment will be made by the 15th of every month for the prior month's sales.
 - o Checks will be mailed to the address above. (Sorry, no cash settlements tendered.)
 - You may use account balance to purchase product from Curated. We offer an additional 5% discount on the purchases using your payment account balance. (Curated absorbs this discount from its portion of the sale, not the consignor of the item being purchased.)
 - If you wish to retrieve any unsold items at the end of your 60-day consignment period, you have 10 days to do so.
 - During the 10 days that your items remain in the store and available for sale. They will be reduced an additional 20% (50% total).
 - If you do not retrieve your items during the ten days, the items automatically become the property of Curated. Curated will dispose of the items as it wishes.
- It is impossible for Curated to monitor the end of the consignment period for each piece in our showroom.
 - You are solely responsible for monitoring the consignment period for your items and will NOT be notified by Curated when your consignment period ends. **Initials:**_____

A buyer's fee (approximately 5% of the item's base price) will be charged to the buyer of your items. You are not charged any fee and this fee does not affect your portion of the sale price. This fee is added to the price of the piece for our processing, basic cleaning, displaying, online advertising and selling and marketing your items to our customers. Please ask to see the schedule of buyer's fees.

DWC bases pricing on supply and demand. It is in your interest as well as the interest of DWC to get the highest possible profit on the sale of your item. You agree that Curated has the final decision on pricing of any consigned item. You also understand that consigned items are subject to markdown or modification at any time by Curated.

Acceptance of items to consign is at the discretion of Curated. All consignment items must be in clean and displayable condition. If any item needs cleaning or minor repairs, Curated will do whatever is necessary to make the item acceptable for sale. The cost of all necessary work will be deducted from the consignor's portion of the proceeds from the sale.

The consignor agrees to all terms herein and certifies he/ she owns the item(s) and has the right to sell them. All items consigned with Curated during the consignment agreement period remain the property of the consignor and may be removed at any time by the consignor. While all reasonable efforts will be made to keep consigned items clean and safe from damage; Curated is not responsible for LOSS or DAMAGE to consigned articles from any and all perils. Please ensure that all items are covered under your homeowner's policy or such other insurance as you deem appropriate.
