## **SECTION 4: First-aid measures**

#### 4.1 Description of first-aid measures

#### **General notes**

Do not leave affected person unattended. Remove victim out of the danger area. Keep affected person warm, still and covered. Take off immediately all contaminated clothing. Vapors are heavier than air, spread along floors and form explosive mixtures with air. Vapors may form explosive mixtures with air.

## Advice on general occupational hygiene
