A popup to select your return label will appear. Ensure this matches the number on the return label found in your package. Click CONFIRM RETURN to complete the process. You will soon receive a confirmation email.  Place the items you wish to return, along with their original packaging, in the box and affix the return label on the outside of the package.  You can drop off your package at any Swisspost subsidiary or at a Päckli Punkt station (find Päckli Punkt stations in your area at http://www.paeckli-punkt.ch/map).
