

HEMP CANNABINOID TESTING SAMPLE INSTRUCTIONS

We accept hemp flower samples (dry or fresh), CBD extract/concentrates and CBD oils/tinctures. If you have special requests or questions, please call us at 910-687-4529 or email us at xzhong@integratedlab.org. Please follow the instructions below when submitting your hemp samples for testing.

For hemp flower samples, it is important that you send us representative samples that will represent the average of your total samples. If you are using the CBD test result to determine the market values, you should send us a representative sample that is equivalent to the hemp flower samples/products for sale.

- 1. Ideally, you can dry your sample in a dehydrator overnight. Then grind your sample briefly (several seconds to a minute) with a clean and dry blender. Send us about 10 to 50 grams (0.5 oz to 2 oz) of dried and ground sample for each sample.**
- 2. For fresh flower material, send us about 50 grams to 100 grams (2 oz to 4 oz) of samples. We will dry the sample overnight for you.**
- 3. Place your sample in a paper bag or Zip bag. Make sure that you label each sample with a sample name (For example: Boax #1) or ID and company name. Zip or staple seal each bag.**

Please fill out the enclosed Hemp Sample Cannabinoid Testing Request Form along with your samples. These forms can be filled out on computer and saved for later use.

For first submission, please fill out and send us the Chain of Title and Affirmation Form.

It is important that the top portion of the testing request form is completed with accurate information. You can mail your sample through USPS mail. Include the order forms and your NC hemp license and mail to the address above.

If your hemp has been tested for THC level by the NC state agency, please also send us a copy of the THC analysis report. However, this is optional and not required.
