

Fee earners at Atkins Thomson are able to dictate both at their workstations and on-the-go in order to create documents, emails and reports. These recordings are converted to text before being automatically imported into customised templates, configured within the SpeechExec Pro Transcribe software.

Files sent via the SpeechLive Cloud-based Service are encrypted end-to-end with the highest 256-bit AES encryption. As well as offering authors unlimited mobility, the voice recordings are transferred securely which means meeting the requirements for robust data security are easily met with very little on-premise software installation required.

Powered by Nuance Dragon Professional Group, authors at the firm are now able to have their dictations automatically transcribed via back-end speech recognition software using Philips PSE4400 SpeechExec Pro Dictate.
