Subject: TSO-C13d Life Preserver, P/N S-7200-(), Model HV-35C Minor Change Request

Dear Mr. Sciortino,

The life preserver drawing S-7200-() has had two minor changes to it. Revision AT, AU and this letter are being submitted to bring our records up to date.

Revision AT, dated 5/15, added part numbers for the S-7200-54X and S-7200-55X assemblies in the Next Assembly and Final Assembly blocks on Sheet 1. These two life preserver assemblies, when worn with our anti-exposure suit form a combined assembly that meets the requirements of TSO-C72c. The Final Assembly part number reflects this combined assembly.

On Sheet 3, the part number S-7200-50X was changed to S-7200-5#X in Note 14. The '#' now represents one of six variations of the X-Back vest (i.e. -50X, -51X, -52X, -53X, -54X and -55X).

Lastly, Note 18 was added. This note references our Switlik Quality Assurance Procedure for testing life preservers.

Revision AU, dated 10/16, removed descriptions from numbered callouts on Sheets 1 and 2 to reduce drawing clutter.

On Sheet 3, two items were added to the Bill of Materials. Item 70 is the Owner's Placard for our X-Back Basic vest, which applies to assemblies -52X and -53X. Item 71 is the Owner's Placard for our X-Back Molle Plus vest, which applies to assemblies -54X and -54X. These assemblies previously used Item 59, HV-35C Owner's Placard. The new owner's placards are tailored specifically to the aforementioned assemblies.

The description of Items 65 and 69 has also been changed. Both items were previously identified as "Jacket Sub-Assy, ETSO Pilot Vest". They are now identified as "Jacket Sub-Assy, X-Back Molle Plus".

Also on Sheet 3, the words "See Note 2" were replaced with a delta Note 2 callout for consistency.

Lastly, the delta Note 18 callout that was added to Item 68 on the last revision was removed. Note 18 applies to all life preservers listed on the drawing, not just Item 68.

These changes should be considered minor as they do not have any effect on form, fit, or function. We hereby certify that this life preserver meets or exceeds all the requirements of TSO C13d, complies with 14 CFR Part 21, Subpart O, and will be manufactured under the strict quality control procedures on file with your Saddle Brook, New Jersey office.
