For dogs and cats the toxic oral doses were 1g and 200mg respectively. After oral administration, the main target organ is the kidney with formation of crystals of calcium oxalate associated with focal necrosis, mineralisation and impairment of kidney function.

The US EPA concluded in 1999 that 0.14mg oxalic acid or oxalate per days represents the human allowable exposure from all sources. No safe dietary dose can be established.
