SAFETY

- Instructing all employees, each within the scope of their respective powers and competences, to take care of their own health and safety and that of the other people involved during operations;
- Sharing the health and safety protection criteria defined in this policy with third party companies called upon to work for the company;
- Making use of the specialised advice of the HSE Department to regularly monitor the application of relevant laws and regulations, integrating them with systematic evaluations, in order to limit the risk of accidents, and with any reports/sanctions imposed by the competent bodies;
- Regularly reviewing the Safety Management System to account for new legislative requirements or the analysis
 of occupational accidents, with the aim of providing all employees with constantly updated information and
 control instruments designed to prevent accidents;
- Involving staff at all levels in ensuring their own health and safety and that of others by providing training and information on the specific characteristics of the places of work;
- Applying prevention measures in the field of health and safety, using methods connected with continuous improvement;
- Bringing contractors on board and encouraging them to adopt suitable risk management strategies by
 organising regular meetings to identify potential risks of interference during work activities and identify suitable
 measures and instruments to prevent or restrict such risks, regularly monitoring their implementation and
 analysing their results.
