



Distribution Contract

Bella Kara

Is a company that is duly constituted with all the formal formalities aimed to develop products in a cream form for the treatment of the human skin, such as the restoration and correction of specific skin problems. In order for creams to be effective, every product in the company catalog must be applied following the specifications given.

The products developed by this company have features that are similar and can be used with absolute confidence with other lines of either esthetic type or allopathic origin containing these same features.

Our products have their due rights protected as far as their formulas are concerned, and their industrial property rights as a professional line, are required for this purpose to have a **Free Sale Certificate**, as evidence that the products listed on the certificate are legally sold or distributed in the open market, freely without restriction, and approved by the regulatory authorities in the country of origin (United States).

In order to merchandise the series of products that the company develops and are included in their detailed inventory programs, this is made available to sales representatives that will properly be called **local distributors**, held for the purpose of this contract with the following clauses detailed below.

CLAUSES

- You must be professionally and adequately trained on the products so that you can give the correct information, product usage & application.
- Supervise / follow-up with clients every 8-15 days for an adequate result.
- Get training for the correct application of the products at the esthetic facial room.
- Have adequate equipment for performing skin analysis, such as a Skin. Scanner machine.
- Initial purchase for Distributor must be \$500.00 dollars plus tax.

- Distributor must maintain a monthly minimum purchase of \$500.00 a month while he introduces the line to his area.
 - If the purchase made is less than \$500.00 dollars, the Distributor will lose his discount and instead will get the sub-distributor price.
 - There will be a List of Aesthetic Prices and in accordance with these same prices, Distributor will receive an additional 30%, 40% or 50% depending on Distributor level. The discount will apply on total due, as a special Distributor price. This is only if he maintains the minimum purchase indicated above.
 - All products will shipped out within 3 to 5 working days depending on the recipient's distance.
 - The total amount of the order will be shipped as soon as a deposit for the full amount is done or confirmed by the main office.
 - **Bella Kara** does not issue credits, exchanges or refunds.
 - **Bella Kara** is free to cancel any distributor immediately if they do not adhere to any of the above regulations as indicated. In turn, they can issue a new Distributorship to any other person at the same location or population within.
1. The Distributor agrees that, beginning on this contract's date, he is responsible for all civil, penal, fiscal, labor and administrative obligations, and in general, all legal responsibilities that may arise from the commercialization of Bella Kara products.
 2. The Distributor agrees not to have exclusive territorial rights.
 3. Bella Kara Inc. agrees that the established product pricing will be consistent throughout the organization. It is also understood and agreed that Bella Kara Inc. shall have the right, from time to time and without notice, to fix and to change its published prices. All distributors must be notified in writing with a 15 day advance notice.
 4. The Distributor shall charge its customers the prices for the respective Merchandise as set forth by Bella Kara Inc.'s published prices as revised from time to time, allowing discounts and/ or net prices in accordance to the Company's established schedules.
 5. This Agreement shall not be assignable by the Distributor either by voluntary act

or by operation by law.

6. Both parties agree that this is a mercantile contract agreement.

7. It is expressly understood that by accepting this Agreement, all prior Agreements are superseded hereby and all claims and demands thereon, except for any amounts that may be due Bella Kara Inc. for Merchandise sold to Distributor, are fully satisfied and hereby released.
