### **MINIMUM ADVERTISED PRICE (MAP):**

Advertising T Bands products below map as set by T Bands is prohibited unless written consent is granted by TRAVON, LLC. Failure to abide by this policy will result in immediate termination as a TRAVON, LLC dealer.

### **INTERNET ADVERTISING POLICY:**

Dealer agrees to sell T Bands product at MAP, which is the price listed for all T Bands products on the T Bands website [www.TBandsUSA.com](http://www.TBandsUSA.com). Dealer may not sell T Bands products on any other website(s). Failure to abide this policy will result in immediate termination as an authorized TRAVON, LLC dealer.

### **GENERAL TERMS & CONDITIONS:**

1. Dealer's opening order must be a minimum of \$500 USD.
2. All T Bands product must be sold by an authorized dealer for warranty to be valid
3. TRAVON LLC reserves the right to inspect all defective merchandise before making a decision on validity of warranty claim.
4. All prices and product are subject to change without prior notice
5. The terms and conditions of this agreement are ongoing and apply to future transactions between TRAVON LLC and the T Bands authorized dealer.
6. Shipping discrepancies or shortages must be reported within 5 days of delivery.
7. Freight damage must be reported to the carrier.
8. Dealer may not sell T Bands product at event locations unless prior written permission is granted by TRAVON LLC.
9. Dealer may not represent itself as "T Bands" Dealer. Dealer may only represent itself as a "T Bands authorized Dealer."
