- Commission Fees are 40% of the retail price of the item. Fee will be deducted automatically before Artisan is sent cheque. (Please double check and make sure your mailing address is correct).
- The retail price of your items *MUST* coincide and be consistent with same or similar items at other locations (including online websites, social media, etc.) you are selling your products.
- From time to time we will have Sales to move stock and keep things fresh. Items that are not sold will be reduced at a lower price with your permission or returned to Artisan.
- No mass-produced or commercially manufactured consumer goods are allowed. If we unknowingly curate in any such items, you will be asked to remove the item(s) in violation without compensation for loss of income or refund of artisan's fees.
- Your images *MUST* be high-resolution marketing-ready at a minimum of 1000px wide (height is irrelevant). Photos will be used for marketing purposes, so use your absolute best product shots.
- All Artisans are responsible for appropriate permits, required product labels, health and safety designations.

CURATION CONSIDERATIONS
