HOW TO ENTER

Visit BSBRAND.COM to complete and submit the online entry form. Follow the directions provided to upload your artwork. Entries are complete when Entrant's artwork has been successfully uploaded.

All entries are FREE. All entries must be received by 11:59 p.m. Pacific Time on March 1st 2021. (the "Standard Deadline"). Each entry must be the original work of the Entrant, and Entrant must be the sole owner of the copyright of such entry. Blackstrap reserves the right, in its sole discretion, to disqualify any entry it deems to be offensive, inappropriate, derogatory, indecent, obscene, hateful, tortuous, defamatory, slanderous, or libelous, that is not in keeping with BlackStrap's image or that is otherwise not in compliance with the terms of these Official Contest Rules. File size limited to 10MB per image. Keep under 1MB per image for smooth uploading.

File renamed with name, art work title, year, i.e., your name, artwork, title, year
