- > IOSH: A selection of IOSH courses can be tailored virtually, however, please note that the Working Safely and Managing Safely are already available as full e-learning qualifications
- NEBOSH: Both the NEBOSH National Diploma and General Certificate in Online Health and Safety are already available as online training
- CITB: SMSTS and SSSTS refresher courses (a minimum of two and a maximum of 10 delegates must be in attendance for these to run), Site Safety Plus Health and Safety Awareness course are available in virtual format. CITB announced on Monday 1 June that classroom-based training can recommence immediately under a risk-based approach. However, this can only take place on the trainer's site as opposed to hotels/other venues where training is usually hosted
- > <u>UKATA</u>: SOCOTEC can provide Asbestos Awareness training in e-learning format, which contains the exact same content as that in the face-to-face course (with certification valid for 12 months)
- Pandemic Awareness and Coronavirus Training: Both of SOCOTEC's pandemic-focussed training courses are available as dedicated e-learning options
