Credit limits given may not equal that requested, this may be due to LaserThings requirement to reduce exposure and does not reflect personally or otherwise on those requesting the credit limit. Some items may be excluded from 30-day trade terms, such as new and used machinery or capital equipment.

Any claim must be made within 7 days of invoice date. Parts sold remain the property of LaserThings Pty. Ltd until payment is made in full. All accounts are 30 days net of invoice date. Any returns/ warranty claims must be authorised by Laserthings Pty Ltd management prior to return. Where any claims or disputes arise, the amount claimed or disputed may be deducted, however the balance must be paid within the original due date.

Warranties.

LaserThings may provide warranties on parts purchased, this includes new, used or refurbished. Warranty periods will vary between part type and supplier. In some cases, extended warranties may be purchased at an additional cost. All LaserThings preused and refurbished parts carry a 1 month (30 day) return policy on faults. This policy does not include any costs associated with replacement, return or repair (including damage (regardless of cause) to any components upstream or down-stream of the supplied part) The pre-used parts are either tested to be fully functional or were fully functional at time of decommissioning.
