The Undersigned Dealer hereby agrees to as follows:

1. Appointment as a Dealer

Dealer agrees to act as an authorized dealer of Volar Motorsport, Inc for the distribution of Volar Motorsport brand products, for Dealer's own account and in ordinary course of its business, to the location's provided. Dealer represents and warrants that it has a state resale or business license and operates on a full-time basis as an established and permanent brick and mortar commercial location.

- i. Definition of a Distributor. A Wholesaler; an individual, corporation or partnership buying products in bulk quantities from Volar Motorsport, Inc. at a specific discount lower than available to dealers, then reselling to dealers in the electric / motorized scooter/ motorcycle industry, but never directly to the general public.
- ii. Definition of a Dealer. A brick and mortar store front business with a permanent fixed business name and /or logo that purchases and maintains an inventory of goods to be sold to the general public.
- iii. Service / Repair Shop & Internet only businesses do also qualify as a dealer.

2. Terms and Condition of Sale

Volar Motorsport may change the product's price list and the term of conditions of sale at any time without written prior notice and liability to Volar Motorsport, Inc from dealer. Payment for products ordered is due prior to shipment of order. Other payment terms may be available only upon approval from Volar Motorsport.

3. Product Warranty

Defective Items are warrant for thirty (30) days from date of purchase. Physical damage or misuse of products will not be covered under warranty. Damages due to shipping or mailing will be responsible through shipping company / carrier. Warranty returns are only accepted from dealer if purchased directly from Volar Motorsport. We offer a fourteen (14) days return policy of unsatisfied products (which products must be in its original condition) from date of purchase subject to a fifth-teen (15) percent of restocking fee.

The Reason for the return shall be submitted in writing and the written note shall be put into the original product packaging. Shipping is the responsibility of the Dealer for all products returned within the fourteen 14 days return policy time period for orders that have been cancelled.

4. Minimum Advertised Price (MAP) Policy

Minimum advertised price can not be below thirty (30) percents of MSRP price as listed on wholesale price list or Dealer Website www.volarmotorsport.com . Failure to comply with (MAP) will be permanently terminate to act as dealer of Volar Motorsport.

5. Nature of Relationship

The Parties intend that relationship created under this Agreement between Volar Motorsport, Inc and Dealer is to be solely that of an independent contractor and vendor.
