## **GENERAL INFORMATION**

**Precision Spreader** is a general purpose spray adjuvant, used to enhance the spreading and coverage of sprays. **Precision Spreader** may be used with insecticides, fungicides, herbicides, PGR's and nutrients at the label use rates or rates recommended on the pesticide label.

# **DIRECTIONS FOR USE**

The addition of adjuvants to some pesticides and/or fertilizers may cause phytotoxicity to plant foliage. Prior to using **Precision Spreader**, the applicator should have experience with the pesticide combination, including **Precision Spreader**, or should conduct a test to determine plant safety.

SHAKE WELL BEFORE USING.

USE WITH PESTICIDES REGISTERED FOR USE ON RESIDENTIAL TURF, COMMERCIAL TURF, TREES, SHRUBS AND ORNAMENTALS.

### **USE RATES**

Type of Application	Amount / 100 gal	Amount / 1 gal
Residential and Commercial Turf	1/2 pt 2 qt.	0.5 – 4 tsp.
Ornamentals	1/2 pt 1 qt.	0.5 – 2 tsp.

#### **MIXING**

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- 1. Compatibility agent and/or antifoam, if needed
- 2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- 3. Dry soluble and suspension fertilizers / micronutrients
- 4. Liquid drift retardants and flowable formulations (F & FL)
- 5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)

- 6. Emulsifiable concentrates (E, EL or EC)
- 7. Solutions and soluble liquids (S or SL)
- 8. Liquid micronutrients and fertilizers
- 9. Water conditioners and other adjuvants

(COC, HSOC, MSO, NIS)

10. Finish filling to desired spray volume level and continue agitation

#### STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
