Credit Application – Agreement to Terms

- 1) Customer represents to Sewer Equipment Co. of America (“Sewer Equipment”) that all the information supplied by Customer in this application is true and correct, and understands that Sewer Equipment will rely upon this information in granting any credit and selling any parts and/or equipment to the Customer.
- 2) Sewer Equipment does not guarantee nor assure that Customer will be given credit or, if given credit, that any credit will continue. Without limitation, Sewer Equipment reserves the right to sell to Customer at any time on pre-paid, C.O.D, or other secured payment basis acceptable to Sewer Equipment.
- 3) If credit is approved by Sewer Equipment, then payment terms will be set along with credit limit. The standard terms are Net 30 days, unless other terms are agreed to in a separate written agreement signed by Sewer Equipment.
- 4) Without limitation on Sewer Equipment rights and remedies on credit issue or any other right under this application, (a) if Customer fails to pay any amount promptly when due hereunder, (b) if Sewer Equipment needs assurance or further assurance of Customer’s credit worthiness, (c) if Customer becomes insolvent, or (d) if Customer is subject to bankruptcy proceedings, receivership or any like related proceeding, then Sewer Equipment may, in addition to any other rights or remedies available to Sewer Equipment in law or in equity, demand different payment terms, suspend or recall deliveries or shipments, impose different credit terms , impose different requirements to secure or assure payment or exercise its rights on any security provided by Customer. Any such demands may be communicated to Customer by oral or written means, at Sewer Equipment’s sole discretion.
- 5) In the event that a customer fails to pay any invoice when due per the agreed upon terms and conditions, (a) Sewer Equipment reserves the right to charge a 1.5% interest penalty on any overdue balance on the first day directly following the stated net terms, (b) Sewer Equipment reserves the right to place Customer on credit hold if any balances go over 60 days past due, (c) Sewer Equipment reserves the right to cancel any pending orders or shipments of Customer if Customer is placed on credit hold, (d) Sewer Equipment reserves the right to forward any past due balances to a collection agency, (e) Sewer Equipment reserves the right to forward any past due balances to an attorney for legal counsel.
- 6) Customer shall be liable for payment of reasonable attorney fees, costs and expenses incurred by Sewer Equipment in attempt to collect any past due amounts. To the extent permitted by law, Customer shall be liable for payment of any charge assessed for or incurred by Sewer Equipment for NSF checks.
- 7) In the event that Sewer Equipment cancels any portion of the Customer debt, Sewer Equipment may file a 1099-C with the IRS.
