### 5. Fire-fighting measures

<b>Extinguishing media</b>	In case of fire, use carbon dioxide, dry chemical, foam, water fog.
<b>Hazardous combustion products</b>	None
<b>Precautions for Firefighters</b>	The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. ### 6. Accidental release measures
