AGREEMENT

- A. The amount reflected on a McGaw invoice, less all applicable offsets and credits, is due and payable in full no later than thirty (30) days from the date of the invoice. If any of the amount owning remains unpaid after its due date, the unpaid portion shall accrue a finance charge of 1.5% per month from the due date until paid.
- B. Buyer shall be liable for a \$25 fee for any check or draft received by McGaw which is dishonored.
- C. Any credit limit shall be set in the sole and exclusive discretion of McGaw, and may be increased or reduced from time to time in McGaw's discretion.
- D. If it becomes necessary for McGaw to take collection action against Buyer to collect any sums owing under this Agreement, Buyer shall be responsible for all reasonable costs of such collection activity, including reasonable attorney fees and court costs.
- E. By submitting this application, you authorize McGaw Graphics, Inc. to make inquiries into banking and trade references that you have supplied, as well as periodic credit checks.
- F. This Agreement is governed by the laws of the State of Vermont, and its place of performance is Bennington County, Vermont.
