The heart and the kidneys are interlocked, with each dependent on the other. As the heart becomes weak, the kidneys are less able to do their job filtering the blood. If the kidneys are impaired, they cannot clear out the wastes and fluid from the blood, making the heart work harder.

It's long been known that a problem with the kidneys dramatically increases the chance of cardiovascular disease. They both share many of the same risk factors for development, such as diabetes and high cholesterol. But, it seems to be high blood pressure that is the critical factor. Angelica, sometimes known as dong quai or wild celery. The volatile oils act on the smooth muscle of visceral organs, and stimulate circulatory and respiratory smooth muscle relaxation. Ferulic acid depresses stimulation of β -2-adrenergic receptors, reducing pulmonary hypertension, correct atrial fibrillation and is a negative inotropic in the heart. Coumarins (dihydroxyranocoumarins & dihydrofuranocoumarins) show coronary vasodilatory, spasmolytic and c-AMP phosphodiesterase inhibiting activity.

The herb astragalus is a historical herbal medicine used for its adaptogenic and blood balancing abilities. The polysaccharides (astragalosides, etc) significantly reduce blood sugar, serum triglycerides and LDL cholesterol, while increasing serum HDL. They help regulate amino acid metabolism. The astragalosides have a positively inotropic action on the heart, stimulate NK cells, and are hepatoprotective. The flavonoids antioxidant activities may inhibit peroxidation and increase the activity of antioxidant enzymes, reducing the risk of coronary heart disease associated with hyperlipidemia and oxidative stress. They may moderate the synthesis of eicosanoids (inhibit phospholipase A2, increase PGF1 and cAMP), and prevent platelet aggregation.

Curcumin has anti-inflammatory and antioxidant effects greater than hydrocortisone. It can inhibit neutrophil function, platelet aggregation, lymphocyte activity, and promotes fibrinolysis. It inhibits the formation of thromboxanes (promotes platelet aggregation) & increasing prostacyclin (inhibits platelet aggregation).

Nigella contains thymoquinone, carvacrol, t-anethole and 4-terpineol, which are responsible for potent antioxidant properties. The compounds lower cholesterol and reduce inflammation (primary thymoquinone derivative).

Salvia (Sage) is one of the most potent and well known herbs, containing caffeic acid, chlorogenic acid, rosmarinic acid, ellagic acid and rutin. It does numerous beneficial things in the body, including lowering cholesterol. Serum creatinine, angiotensin II (Ang II), transforming growth factor β 1 (TGF- β 1) and collagen IV levels were significantly reduced under the use of Salvia, protecting the kidneys.
