For Will Call orders, if orders are not picked up **within 3 days**, orders will be automatically cancelled and charged a 15% restocking fee. (The fees will be automatically deducted from our Guarantee Policy).

When placing orders, it is our policy to charge for items to be placed into production, followed by a freight amount at the time of shipping.

There will be a 15% restocking fee on all returned/refused merchandise, policy is not limited to returned merchandise that is used or mounted.
