THERMOBREAK[®] PRODUCT WARRANTY

Warranted Products:

Thermobreak[®] Sheet, Thermobreak[®] Tube, Thermobreak[®] 9705, Thermobreak[®] Acoustiplus, Thermobreak[®] LS, Thermobreak[®] LSH, Thermobreak[®] RT, Thermobreak[®] Thermacoil (Insulation only).

Conditions of Warranty:

Sekisui Pilon Pty Ltd and Thai Sekisui Foam Company Ltd (hereinafter collectively referred to as Sekisui Foam International), hereby confirms that the above mentioned Thermobreak[®] range of insulation products are manufactured to ISO9001:2008 quality standards in accordance with Sekisui Foam International's product specification schedule and, where applicable, manufactured in compliance with insulation material standards AS/NZS 4859.1 and ASTM C1427.

The above Thermobreak[®] insulation products, sold only by Sekisui Foam International or its authorised distributors, are warranted on delivery to be of the quality herein specified. In particular, these products are warranted against defects not due to normal wear or tear, for a period of 10 years from date of purchase.

This warranty is subject to the following:

1. Thermobreak[®] being stored and handled in accordance with current Sekisui Foam International recommendations.
2. Installation being carried out by a qualified tradesperson in accordance with current Sekisui Foam International Installation Instructions as described in the Thermobreak[®] Information Kit, current as of the date of installation.
3. Thermobreak[®] purchased from an authorised distributor for a particular country is expressly used only within that country.
4. Thermobreak[®] insulation is physically protected in any installation where it may be exposed to external weathering.
5. Paint or other coatings are not directly applied to Thermobreak[®] insulation.

This warranty excludes claims on defects caused by the following:

1. UV degradation or other defects caused by external weathering.
2. Abnormal natural disasters or forces including, but not limited to floods or rain damage.
3. Exposure to excessive mechanical damage, including being regularly walked or stood on.
4. Exposure to chlorides (including salt water or spray), fluorides, acids (< pH 4), bases (>pH 10) or other strong chemicals known to corrode aluminium foil.
5. Exposure to temperatures outside the specified range for Thermobreak[®] or any factory applied adhesive.

In the event of a claim Sekisui Foam International's sole obligation shall be, at its option, to supply replacement Thermobreak[®] material, so deemed faulty by authorised employees of Sekisui Foam International. Sekisui Foam International's liability shall be limited to the replacement cost of the faulty material discounted proportionately to the ratio of the warranty period not achieved relative to the full warranty period. Sekisui Foam International shall not be liable for any labour costs, injury, damage, or any consequential costs associated with replacing faulty material.

Furthermore, Thermacalc[™] recommended thickness calculations are based on standard published formulae based on ASHRAE and British Standard recommendations and are provided in good faith. Sekisui Foam International accepts no liability for the interpretation and utilisation of the information therein.
