Range Rules

These range rules are for everyone's protection and range enjoyment. Abuses of range rules can not and will not be tolerated. You are expected to read and understand them before using the range. Safety is everyone's business.

Security Cameras are in use 24/7 on all outdoor ranges/facilities and inside and outside the clubhouse.

1. Always point the muzzle in the safe direction.
2. Keep your finger off the trigger until you are ready to shoot.
3. Keep the action open and the firearm unloaded until you are ready to shoot.
4. Know how your firearm operates.
5. Be sure your firearm and ammunition are compatible.
6. Carry only one caliber/gauge of ammunition when shooting.
7. Be sure of your target and what's beyond.
8. Eye and ear protection are required.
9. Do not use alcohol or drugs prior to shooting .No alcohol is permitted on any range.
10. Circumstances may require additional rules or rule changes at any time.
11. A passive range officer policy will be in effect at all times. This means that the first member arriving at the range will be the officer in charge. When this officer leaves the range, he/she will select another shooter to assume this role, in turn until the last shooter has departed.
12. Shooting hours: Monday – Friday . 8:00 A.M. to 10:00 P.M.
 Saturday & Sunday 9:00 A.M. to 2:00 P.M.
13. No firing of fully automatic firearms is allowed. No continuous rapid firing of any firearm in the excess of eight (8) rounds. No Star Exploding targets, or similar devices are allowed.
14. A common firing line will be observed for all types of shooting. This line will be 100 yards back from the sand embankment. No one will shoot from behind or from in front of this firing line except during a range officers supervised event.
15. All firearms will be unloaded, pointing down range, with the actions open when not being fired. Before anyone goes down range to check or hang targets, all firearms must be put down unloaded. Safety flags must be put in place and all clear confirmed.
16. ***No one is to handle any firearm when anyone is down range.***
17. All shots will be fired, so they go directly into the sand embankment
18. All firearms will be handled in a safe and responsible manner anywhere on club property at all times.
19. No loud distracting or boisterous behavior will be permitted on or near the firing line.
20. Members will have priority over guests for use of a firing point.
21. A paid up membership card is proof of membership.
22. All rubbish will be picked up and placed in the trash receptacles.
23. No breakable targets of any kind are allowed on the ranges, except on supervised field day activities. No metal targets of any kind are allowed on the ranges. This includes all commercially available spoon, spinner, silhouette, or any target made of metal, regardless of intended caliber. The only exceptions are club sanctioned events under the direct control of the Rifle and Pistol Committee.

24. Targets and brass and broken strapping will be picked up and properly disposed of upon completion of firing in the rubbish container provided. Misfired shells are to be picked up and disposed in the proper solvent containers provided. **NO SHOOTING AT VERTICLE POSTS. NO HANGING TARGETS FROM ANY VERTICLE POSTS AT ANY RANGES. ATTACH YOUR TARGETS TO THE HORIZONTAL STRAPPING ONLY!** Replace any broken strapping after you are done shooting for the day. Replacement strapping is available in an above hanging rack located in the pistol range shelter.
25. Whenever the command “CEASE FIRE” it is given, everyone on the firing line will immediately cease firing, unload his or her firearm, open the action and place the firearm on the table with the muzzle pointing down range.
26. Anyone noticing any unsafe condition will immediately give the command to “CEASE FIRE” and then take whatever steps are necessary to correct the unsafe condition as quickly and as safely as possible.
27. All orders or instructions given by a range officer must be obeyed immediately and without question. If you have a question regarding in order or instruction, make a note of it and ask the question after all firearms have been secured in a manner described in paragraph 25.
28. It is the responsibility of each and every individual firing to make certain that no unsafe conditions exist on any range at any time, and when in unsafe condition is spotted, that it is corrected immediately.
29. Any member who violates any of these rules herein described is subject to written reprimand from the Board of Directors and possible expulsion from the club as prescribed in section 10 .4 of the bylaws.
30. The Marine Corps League and the Acton Police Department will have use of the outdoor rifle and pistol ranges as guests of the club. Generally their events will be quarterly and scheduled on weekdays in advance to minimize the impact on range availability to our members. The range will be closed to members during these events. Notice of these events will be emailed to members and posted on the clubhouse bulletin board. Please check in advance if you decide to do some shooting.
