## Your Role:

• The Bright Black Production Associate has responsibility for handcrafting small batch, high-quality candles. The Production Associate will also support fulfillment and shipping activities, vendor market participation, and Bright Black Scent Showroom/Creator Studio staffing. The ideal candidate will be able to balance pace and accuracy, in an effort to hit daily target production and quality goals. This position is part-time, but may evolve into a full-time role in the future. Specific hours will be determined in partnership with the chosen applicant based on both parties' needs.

- Handcrafts small-batch candles.
- Finishes poured candles using processes designed by Bright Black co-founders.
- Prepares, cleans and labels candle vessels.
- Cuts and assembles wicks.
- Measures wax and oils.
- Supports shipping activities including packaging finished candles for fulfillment.
- Assists with monitoring supplies and inventory.
- Maintains a clean, neat, safe and orderly work area.
- Upholds the highest standard of artisanship.
- Welcomes and engages with customers as they enter the Bright Black Creator Studio/Showroom
- Works with cash register and process payments at Craft/Makers Markets and/or the Bright Black Showroom
- Gives customers advice about products, sales and promotions
- Cleans and restocks the store throughout the day, before opening and after closing
- Other responsibilities as requested
