



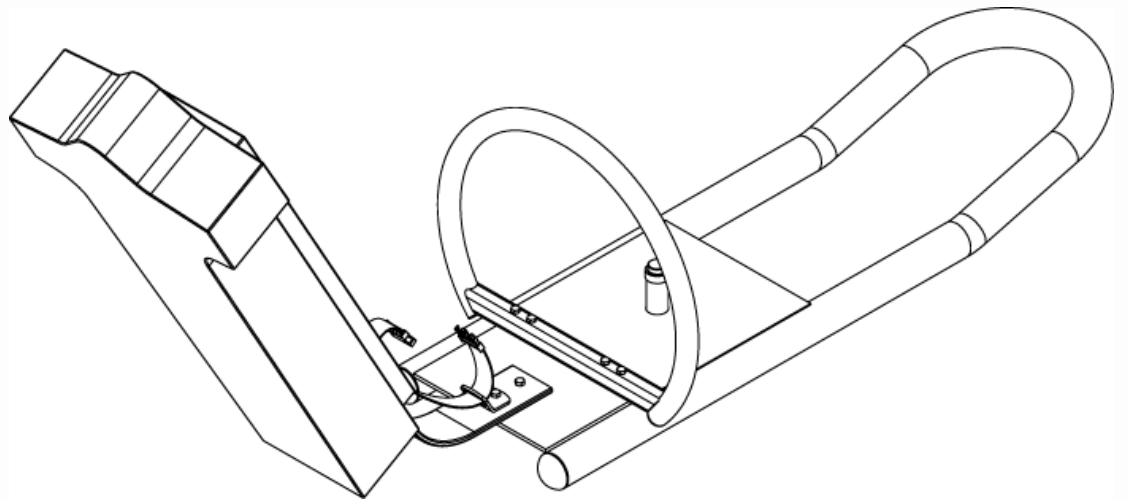

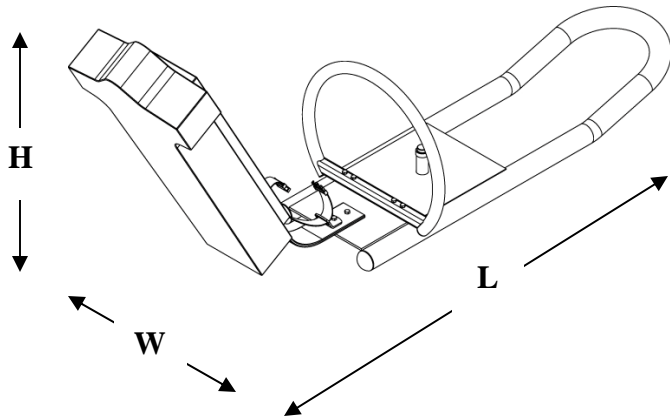
- **Supervision of athletes while using the equipment is recommended.** Horse play such as climbing on the machine or using the machine for unintended purpose can result in injuries.

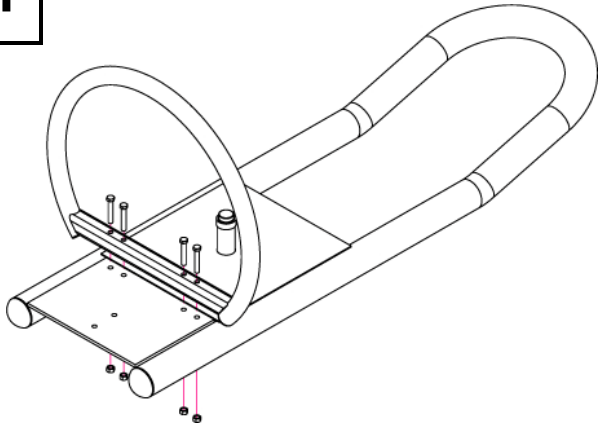
- Once tackled to the ground, sled returns to the upright position in seconds.

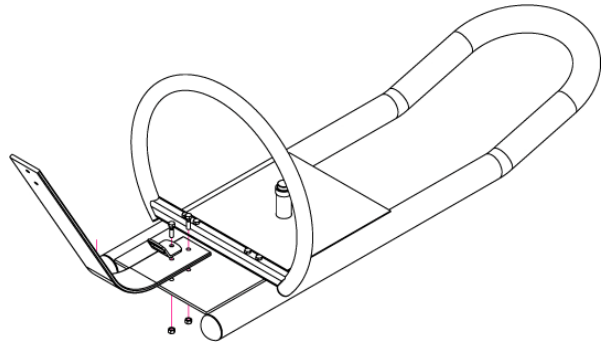

Note: 2 people required for assembly.

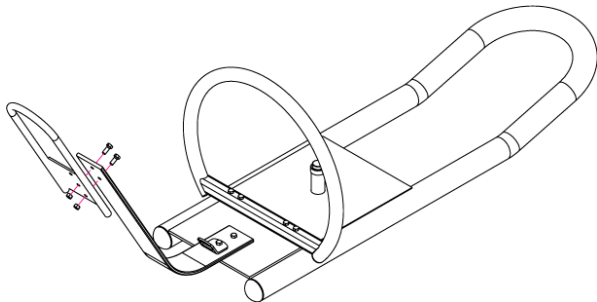
Affix the Tackle Sled Hoop to the Tackle Sled Runner using (4) $\frac{1}{2}$ " x 3" bolts and (4) $\frac{1}{2}$ " nuts. This step is easiest with another person to help lift the sled on its side as you place the bolts.

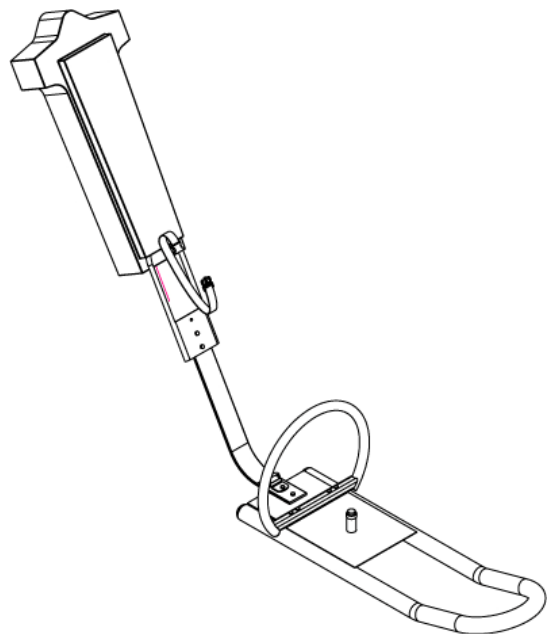
Use (2) $\frac{1}{2}$ " x $1\frac{3}{4}$ " bolts and (2) $\frac{1}{2}$ " nuts to connect the Tackle Sled Leaf Spring and the Tackle Sled Pad Strap Bracket to the front of the sled assembly.

Attach the Tackle Sled Pad Frame to the leaf spring with (2) $\frac{1}{2}$ " x $1\frac{1}{2}$ " bolts and (2) $\frac{1}{2}$ " nuts.

Slip Pad over Tackle Sled Pad Frame, thread pad strap through the Pad Strap Bracket, and connect the buckles. Pull strap tight.
