2. No salesperson, representative or agent is authorised by Minelab to give any guarantee, warranty, or representation in addition to, or contrary to these Terms and Conditions.
3. Submitting a claim or participation in this Offer is deemed acceptance of these Terms and Conditions.
4. Information on how to enter this Offer forms part of these Terms and Conditions.

ELIGIBILITY

7. The Offer is only open to eligible claimants. An “**Eligible Claimant**” is a person who:
 - a. is either an Australian citizen or resident;
 - b. submits a registration application for this Offer in accordance with these Terms and Conditions;
 - c. registers the redemption for himself or herself exclusively and not on behalf of any other person or group of persons;
 - d. does not in any way tamper with the Offer and/or the registration process for the Offer; and
 - e. purchases one of the Eligible Minelab Products set out in clause 16 below from a [Minelab Certified Dealer](#) in Australia only (**Eligible Purchases**).

ELIGIBLE AND EXCLUDED PRODUCTS

8. This redemption does not apply to any non-Eligible Minelab Products during the Redemption Period or any products purchased outside of the Redemption Period.
9. This redemption only applies to the below Eligible Minelab Products set out in clause 18 of these Terms and Conditions that are purchased from Certified Minelab Dealers during the Redemption Period.

HOW TO REDEEM THE REDEMPTION OFFER

10. To redeem a Minelab Equinox 600 Metal Detector (**Redeemable Product**), you must, during the Redemption Period:
 - a. purchase a brand new Minelab GPZ 7000 Metal Detector (**GPZ 7000**) from any participating [Certified Minelab Dealer](#) (not Retailer) during the Redemption Period;
 - b. register your details online at <https://www.minelab.com/gpx-gpz-redemption>;
 - c. fill out the application form. You must complete all required fields;
 - d. upload your proof of purchase (which will include an image of the Minelab Product, your receipt and the serial number of the Minelab Product); and
 - e. submit your form.

11. To redeem a Minelab GPX 17” Coil (**Redeemable Product**), you must, during the Redemption Period:
 - a. purchase a brand new Minelab GPX 6000 Metal Detector (**GPX 6000**) from any participating [Certified Minelab Dealer](#) (not Retailer) during the Redemption Period;
 - b. register your details online at <https://www.minelab.com/gpx-gpz-redemption>;
 - c. fill out the application form. You must complete all required fields;
 - d. upload your proof of purchase (which will include an image of the Minelab Product, your receipt and the serial number of the Minelab Product); and
 - e. submit your form.
12. The actions described in either clause 10 or 11 are hereafter referred to as a **Redemption Claim**. Once you have submitted a Redemption Claim, you will receive an email notification to the email provided confirming the Redemption Claim has been submitted. Your application will then be verified by Minelab. You will be notified within 3 weeks of submission of your Redemption Claim if the Redemption Claim is successful.
13. To redeem AU\$400 instant cashback (**Cashback Redemption**), you must, during the Redemption Period:
 - a. purchase a brand new Minelab GPX 6000 Metal Detector (**GPX 6000**) from any participating [Certified Minelab Dealer](#) (not Retailer) <https://www.minelab.com/gpx-gpz-redemption>; and
 - b. at the time of purchase of the GPX 6000 from the Certified Minelab Dealer, prior to the purchase transaction occurring, notify the Certified Minelab Dealer that you elect to redeem the Cashback Redemption.
14. To redeem AU\$500 instant cashback (**Cashback Redemption**), you must, during the Redemption Period:
 - a. purchase a brand new Minelab GPZ 7000 Metal Detector (**GPZ 7000**) from any participating [Certified Minelab Dealer](#) (not Retailer) <https://www.minelab.com/gpx-gpz-redemption>;
 - b. at the time of purchase of the GPZ 7000 from the Certified Minelab Dealer, prior to the purchase transaction occurring, notify the Certified Minelab Dealer that you elect to redeem the Cashback Redemption.

REDEMPTION PERIOD

15. Eligible Purchases must be made between 12:00AEST 22/09/2023 and 23:59AEST 22/10/2023. Any purchases made outside of this period are invalid and will be excluded from this redemption.
16. Redemption Claims must be submitted on or before 23:59AEST 26/11/2023. Any Redemption Claims submitted after this time are invalid and will be excluded from this redemption.
17. Stock of the Redeemable Product is limited and the Offer will only be valid strictly while stocks lasts. Once stock of any product included in the Offer has been exhausted, the Offer will cease.

ELIGIBLE MINELAB PRODUCTS:

18. This Offer is applicable only to purchases of brand new GPX 6000 or GPZ 7000 in Australia from a [Certified Minelab Dealer](#). This Offer does not apply to any products other than the GPX 6000 and GPZ 7000 purchased during the Redemption Period and the offer excludes any products purchased outside of the Redemption Period set out above in clauses 15, 16 and 17 of these Terms and Conditions.
19. **Warranty:** The standard manufacturer’s warranty remains unchanged.

DELIVERY OF REDEEMABLE PRODUCT:

20. A Redeemable Product will be sent directly to the postal address advised by you in the

Redemption Claim. You are responsible for ensuring that you enter the correct address and Minelab cannot be held responsible for, and have no liability to reissue, any redeemed products which are delivered to an incorrect address, other than by our own error. Minelab cannot deliver to PO Boxes. Participants must provide a valid street address for delivery of the Redeemable Product.

- a. If you cannot provide a valid street address, or Minelab are unable to (or decide not to) deliver to your street address, Minelab will deliver your Redeemable Product to the nearest Certified Minelab Dealer. In this situation it will be your responsibility to arrange for your Redeemable Product to be collected at your cost. Minelab's decision not to deliver to any address, and to alternatively deliver to a Minelab Certified Dealer, will be final and at Minelab's sole discretion.
21. Please allow up to 6 weeks from submission of the completed/submitted Redemption Claim for the Redeemable Product to reach your address (or the selected Minelab Certified Dealer).
 22. Claims will only be considered complete once a copy of a valid receipt has been received, the claim verified by Minelab and the Redeemable Product dispatched.
 23. You must retain the confirmation email from Minelab as proof of submission.
 24. The Redeemable Product is non-transferrable, non-negotiable, non-exchangeable and non-refundable, except to the extent that any faulty Redeemable Product are subject to the statutory rights under the Australian Consumer Law.

DELIVERY OF CASHBACK REDEMPTION:

25. The Cashback Redemption will be provided to you at the time of purchase of an Eligible Product in accordance with these Terms and Conditions.
26. The Cashback Redemption is non-transferrable, non-negotiable, non-exchangeable and non-refundable.

ONE REDEMPTION OFFER PER ELIGIBLE PRODUCT:

27. Only one (1) redemption can be claimed per transaction. If an Eligible Claimant purchases more than one (1) Eligible Products, an Eligible Claimant may only claim once per transaction.
28. To avoid any doubt, you cannot claim both a Redeemable Product and the Cashback Redemption within the same transaction.
29. To be eligible for the redemption, the product purchased cannot be purchased or used in conjunction with any other offer.

GENERAL

30. **Lost claims:** Responsibility will not be accepted by Minelab for claims lost, damaged or delayed.
31. **Verification:** Minelab reserves the right, at any time, to verify the validity of entries and Eligible Claimants (including an Eligible Claimant's identity and place of residence) and to disqualify any Eligible Claimant who submits a registration that is not in accordance with these Terms and Conditions or who tampers with the registration process.
32. **Forms of verification:** suitable forms of verification are at the discretion of Minelab, and these include checking the validity of purchases with the Minelab Certified Dealer network as appropriate. Errors and omissions may be accepted at Minelab's discretion.
33. **Incomplete claims:** Incomplete or illegible claims will not be accepted. Incomplete claims may include proof of purchase which fails to include any of the following: date and time of purchase, place of purchase, purchase price and/or model of product. Minelab may reject such claims that fail to meet these criteria. Furthermore, if there is any reason to believe that a claimant has breached these Terms and Conditions or incorrect, illegible, fraudulent, or other invalid or improper information has been provided, Minelab may, in its sole discretion, immediately reject such claim(s).
